WHEREAS, it is found necessary to control and harmonize any social and economic development activities so as not to impose an impact on sustainable development by polluting the environmental resources;

WHEREAS, it is found necessary to develop transparent and accountable pollution control and monitoring system in order to minimize or eliminate the pollution effect on the environment;

Qaama naannoo fi fayyummaa hawaasaa irratti miidhaa geessise irratti tarkaanfiin sirreeffamaa fudhatamu ifatti kaa'uun barbaachisaa ta'ee waan argameef;

Akkaataa Heera Mootummaa Naannoo Oromiyaa Fooyya'ee Bahee Labsii Lak. 46/1994 Keewwata 49(3)(a)tiin kan kanatti aanu labsamee jira.

1. Mata Duree Gabaabaa

2. Hiika

Akkaataan jechichaa hiika biroo kan kennisiisuuf yoo ta'e malee, Labsii kana keessatti:

- 2) "Biiroo" jechuun Biiroo Lafa Baadiyyaa fi Eegumsa Naannoo Oromiyaa fi caasaalee isaa jechuudha.

፩) "መንግሥት" ማለት የኦሮሚያ ብሔራዊ ክልላዊ መንግሥት ነው፡፡

፪) "ቢሮ" ማለት የኦሮሚያ ገጠር መሬትና አካባቢ ጥበቃ ቢሮና በየደረጃው የሚገኙ መዋቅሮች ማለት ነው፡፡

፫) "አካባቢ" ማለት በአጠቃላይ የሰው ልጅ እና ሕይወት ያላቸው ነገሮች እንቅስቃሴ እንዲሁም በመሬት፣ በአየር፣ በውሃ፣ በድምፅ በሽታ፣ በጣኦም፣ በማህበራዊ ኑሮና በሥነ ወበት ላይወሰን በሰው አማካኝነት ተሻሽለው ወይም ተለውጠው የሚገኙ ነገሮች በሙሉና ያሉበት ቦታ፣ እንዲሁም መጠናቸው ወይም ሁኔታቸው የሰውና ወይም የሌሎችን ህያዋንን በጎ ሁኔታ የሚጎዱ የመከተጋቢያቸው ድምር ነው፡፡

WHEREAS, it is found necessary to clearly put the rights and obligations of those involve in development activities to give emphasis and play their role in environmental protection;

WHEREAS, it is found necessary to make laws enacted ragarding environmental pollution control as a country compatiabile to the regional context;

WHEREAS, it is found necessary to clearly put corrective measures to be taken on those bodies that adversely affect the human health and the environment;

NOW, THEREFORE, in accordance with the Revised Constitution of the National Regional State of Oromia Proclamation No. 46/2001 Article 49(3) (a) it is hereby proclaimed as follows:

PART ONE GENERAL

1. Short Title

This Proclamation may be cited as the "Oromia National Regional State Environmental Pollution Control Proclamation No.177/2012."

2. Definitions

Unless the context requires otherwise, in this Proclamation:

- 1) "Government" means the National Regional Government of Oromia.
- 2) "Bureau" means Oromia Rural Land and Environmental Protection and its structures at different levels.
- 3) "Environment" means the totality of all materials whether in their natural state or modified or changed by humans, their external spaces and the interactions which affect their quality or quantity and the welfare of human or other living beings, including but not restricted to land, air, water, sound, odor, taste, social factors, and aesthetics.

- 4) **“Eegumsa Naannoo”** jechuun qabeenya naannoo kamiyyuu osoo miidhaan irra hin gahin, hin faalaminii fi hin xuraa’iin kunuunfamee haala itti fufiinsa qabuun akka faayidaa kennu taasisuu jechuudha.
- 5) **“Miidhaa”** jechuun misooma gaggeeffamu kamiyyuu keessatti hubaatii qabeenya naannoo, fayyaa namaa fi sirna xinqeeyyaa irra gahu kamiyyuu jechuudha.
- 6) **“Keemikaala”** jechuun elementii yookiin kompaawundii yookiin makaa, namaan yookiin industriidhaan kan qophaaye yookiin uumamaan kan argamu jechuudha.
- 7) **“Keemikaala Hamaa”** jechuun elementii yookiin kompaawundii namaan qophaaye yookiin uumamaan jiru ta’ee, naannoo, fayyaa namaa fi lubbu qabeeyyii biroo irratti miidhaa hamaa geessisuu kan danda’u jechuudha.
- 8) **“Gataa”** jechuun wanta dhangala’aa, jajjaboo yookin gaasii ta’ee madda adda addaa irraa kan bahu naannoo fi fayyaa namaa irratti miidhaa geessisuu kan danda’u jechuudha.
- 9) **“Yaa’aa”** jechuun bishaan, gaasii yookiin dhangala’aa biroo, xuriin isaanii kan yaalame yookiin osoo hin yaalamin kallattiidhaan yookiin al-kallattiin naannootti kan gad-lakkifamu jechuudha.
- 10) **“Wanta Hamaa”** jechuun dhangala’aa, wanta jajjaboo, yookiin gaasii ta’ee lubbu qabeeyyii, fayyaa namaa fi naannoo irratti miidhaa geessisuu kan danda’u jechuudha.
- 11) **“Faalama”** jechuun Labsii kanaan yookiin seera biroottiin, dirqama daangaa yookiin dhoorkaa tumame cabsuudhaan haala fizikaalaa, keemikaalaa, albuudaa, ho’ina yookiin sirna lubbu qabeeyyii yookiin amala naannoo jijjiiruudhaan fayyaa namaa fi lubbu qabeeyyii kan birootiif haala hamaa kan ta’e yookiin ta’uu kan danda’u jechuudha.
- 12) **“Gataa Hamaa”** jechuun gataa kamiyyuu naannoo yookiin fayyaa namaa fi lubbu qabeeyyii kan biroo irratti wanta miidhaa geessisuu danda’u jechuudha.

፬) **“የአካባቢ ጥበቃ”** ማለት በማንኛውም የአካባቢ ሀብት ላይ ተፅዕኖ ሳይደርስ፣ ሳይበክልና ሳይቆሽሽ ተንከባክበው ቀጣይነት ባለው ሁኔታ አገልግሎት እንዲሰጥ ማድረግ ማለት ነው።

፭) **“ጉዳት”** ማለት በማንኛውም የልማት እንቅስቃሴ ውስጥ በአካባቢ ጉዳት፣ በሰው ጤና እና በስነምግባር ላይ የሚደርስ ማንኛውም ጉዳት ማለት ነው።

፮) **“ኬሚካል”** ማለት ኢለመንት ወይም የተቀላቀለ ውህድ ወይም ቅይጥ ሆኖ ተቀምጦ በሰው የተዘጋጀ ወይም በተፈጥሮ የተገኘ ቁስ አካል ነው።

፯) **“አደገኛ ኬሚካል”** ማለት ኢለመንት ወይም የተቀላቀለ ውህድ ሆኖ ተቀምጦ በሰው የተዘጋጀ ወይም በተፈጥሮ የተገኘ ሆኖ በአካባቢ፣ በሰው ጤናና ሌሎች ሕያዋን ላይ አደገኛ ጉዳት ሊያደርስ የሚችል ማለት ነው።

፰) **“ቆሻሻ”** ማለት ፍላጎት፣ ጠጣር ወይም ጋዝ ሆኖ ከተለያዩ ምንጮች የሚለቀቅ ሆኖ በአካባቢና በሰው ጤና ላይ ጉዳት ሊያደርስ የሚችል ማለት ነው።

፱) **“ፍላጎት”** ማለት ውሃ፣ ጋዝ ወይም ሌላ ፍላጎት ተጣርቶ ወይም ሳይጣራ በቀጥታ ወይም ቀጥታ ባልሆነ መንገድ ወደ አካባቢ የሚለቀቅ ማለት ነው።

፲) **“አደገኛ ነገር”** ማለት ፍላጎት፣ ጠጣር ወይም ጋዝ ሆኖ በሰው ጤናና በአካባቢ ላይ ጉዳት ሊያደርስ የሚችል ነው።

፲፩) **“ብክለት”** ማለት በዚህ አዋጅ ወይም በሌላ ሕግ የተደነገገውን ግዴታ ወይም ገደብ ጥሶ የአካባቢን ቁሳዊ፣ ኬሚካላዊ፣ ማዕድን፣ ሙቀታዊ ወይም ስነ-ህይወታዊ ወይም የአካባቢ ባህርይ በመለወጥ በሰው ጤና እና ሌሎች ሕያዋን ላይ አደገኛ የሆነ ወይም አደገኛ ሊሆን የሚችል ሁኔታ ማለት ነው።

፲፪) **“አደገኛ ቆሻሻ”** ማለት ማንኛውም ቆሻሻ በአካባቢ ወይም በሰውና ሌሎች ሕያዋን ጤና ላይ ጉዳት ሊያደርስ የሚችል ነገር ነው።

4) **“Environmental Protection”** means the protection of any environmental resources from damage, pollution, and wastes for its sustainable utilization.

5) **“Damage”** means any harm that can be posed by any development activity on environmental resources, human health and the ecosystem.

6) **“Chemical”** means an element or a compound whether by itself, or in a mixture or prepared by human being, whether manufactured or obtained from nature.

7) **“Hazardous Chemical”** means an element or a compound prepared or obtained in nature that has the ability to deleterious effect on the environment, human health and other living creatures.

8) **“Wastage”** means whether it is liquid, solid or gas discharged from different activities that can harm the environment and human health.

9) **“Effluent”** means waste water, solid or gas, treated or untreated, discharged directly or indirectly into the environment.

10) **“Hazardous Material”** means substances in liquid, solid or gaseous state that can damage living beings, human health and the environment.

11) **“Pollution”** means any condition which is hazardous, or potentially hazardous to human health and other creatures by altering any physical, chemical, mineralogical, thermal or biological or other property of the environment in contravention of any condition, limitation or restriction made under this proclamation or under any other relevant law.

12) **“Hazardous Waste”** means any waste material that is deleterious to the environment, human health and other living creatures.

13) **“Faaltota”** jechuun wanta jajjaboo yookiin dhangala’aa yookiin gaasii yookiin sagalee ta’ee kallattiinis ta’e al-kallattiin, sadarkaa qulqullina naannoo jijjiiruudhaan tajaajila naannicha irraa argamuu danda’an kan miidhu yookiin fayyaa namaa yookiin lubbu qabeeyyii biroo fi naannoo irratti miidhaa geessisuu kan danda’u, kan akka summii, dhibee, foolii, ajaa, aara, qaayyoota, raadiyo-aktiivii, sagalee, ho’ina hamaa yookiin miidhaa biroo kan uumuu danda’u jechuudha.

14) **“To’annoo Faalama Naannoo”** jechuun pirojektootaa fi misoomni gaggeeffamu kamiyyuu naannoo irratti miidhaa akka hin geessisne hordofuu, deeggarsa ogummaa kennuu fi tarkaanfii sirreessaa fudhachuu jechuudha.

15) **“Faaluu”** jechuun beekaas ta’e yookiin osoo hin beekin faaltota gara naannootti gad-lakkisuu jechuudha.

16) **“Faalama Sagalee”** jechuun sagalee hanga sadarkaa ol ka’iinsa hayyamameen ol ta’ee fayyaa namaa yookiin nageenya naannoo jeequ kamiyyuu jechuudha.

17) **“Laaboraatoorii”** jechuun bakka saamudni adda addaa itti sakatta’amu jechuudha.

18) **“Jaarmiya”** jechuun dhaabbata hojii irra jiru, haarawaa ijaaramaa jiru, hojii misoomaa yookiin tajaajila kennu yookiin hojii kan biroo irratti bobba’ee kallattiinis ta’e al kallattiin adeemsa hojii isaa keessatti naannoo yookiin fayyaa namaa irratti dhiibbaa geessisuu kan danda’u jechuu dha.

19) **“Qooda Fudhattoota”** jechuun naannoo Oromiyaa keessatti qaama mootummaa yookiin miti-mootummaa yookiin abbaa qabeenyaa hojii eegumsa naannoo isa ilaallatu kamiyyuu jechuudha.

20) **“Nama”** jechuun nama uumamaa yookiin qaama seeraan namummaa argate jechuudha.

፲፫) **“ባካይ”** ማለት ጠጣር ነገሮች ወይም ፍሳሽ ወይም ጋዝ፣ ወይም ድምፅ ሆኖ በቀጥታም ሆነ ቀጥታ ባልሆነ መንገድ የአካባቢን ጥራት በመለወጥ ጠቀሜታ የመስጠት አቅሙን የሚጎዳ ወይም በሰው ጤና ወይም በሌሎች ሕያዋን ላይ ጉዳት ሊያደርስ የሚችል እንደ መርዝ፣ በሽታ፣ ሽታ፣ ክርፋት፣ ጭስ፣ ጨረር፣ ድምፅ መቶት ወይም ሌላ ጉዳት ሊፈጥር የሚችል ክስተትን የሚያመነጭ ማንኛውም ነገር ማለት ነው።

፲፬) **“የአካባቢ ብክለት ቁጥጥር”** ማለት ማንኛውም የሚተገበሩ ፕሮጀክቶችና የልማት ሥራዎች በአካባቢ ላይ ጉዳት እንዳያደርሱ መከታተል፣ መያዝ ድጋፍ መስጠትና የአርምት አርምጃዎችን መውሰድ ማለት ነው።

፲፭) **“መበከል”** ማለት በማወቅ ወይም ባለማወቅ በካይ ነገሮችን ወይም አካባቢን የሚያውክ ማንኛውም ድምፅ ማለት ነው።

፲፮) **“የድምፅ ብክለት”** ማለት ከመጠን ያለፈ ድምፅ ሆኖ በሰው ጤና ወይም አካባቢን የሚያውክ ማንኛውም ድምፅ ማለት ነው።

፲፯) **“ቤተ መተራ”** ማለት የተለያዩ ናሙናዎች የሚመረመሩ ቦታ ማለት ነው።

፲፰) **“ድርጅት”** ማለት በሥራ ላይ ያለ፣ እየተገነባ ያለ፣ የልማት ሥራ ወይም አገልግሎት የሚሰጥ ወይም በሌሎች ስራዎች ላይ የተሠማራ ሆኖ በቀጥታም ሆነ ቀጥተኛ ባልሆነ መንገድ በሥራው ሂደት በአካባቢ ወይም በሰው ጤና ላይ ተፅዕኖ ሊያደርስ የሚችል ማለት ነው።

፲፱) **“የባለድርሻ አካላት”** ማለት በአሮሚያ ክልል ውስጥ የአካባቢ ጥበቃ ጉዳይ የሚመለከታቸው ማንኛውም መንግስታዊ ወይም መንግስታዊ ያልሆኑ አካላት ወይም ባለሀብት ማለት ነው።

፳) **“ሰው”** ማለት የተፈጥሮ ሰው ወይም በሕግ የሰውነት መብት የተሰጠው አካል ማለት ነው።

13) **“Pollutant”** means any substance whether solid, liquid or gas or sound which directly or indirectly alters the quality of any part of the receiving environment so as to adversely affect its beneficial use or produces toxic substances, diseases, objectionable odor, smoke, fog, radioactivity, noise, heat that is hazardous to human health or to other living things.

14) **“Environmental Pollution Control”** means monitoring, provision of professional support and taking corrective measures to reverse the adverse impact of any project and development activity.

15) **“Pollute”** means releasing pollute materials/ things to the environment whether knowingly or unknowingly.

16) **“Noise Pollution”** means any noise that exceeds the permissible noise level and can affect human health or disturb the environment.

17) **“Laboratory”** means the place where different samples are analyzed.

18) **“Organization”** means an existing, new on construction that deployed on development activity or service rendering or other activities which directly or indirectly posed impact on the environment and human health.

19) **“Stakeholders”** means any governmental or non-governmental organizations or investors in Oromia Region that are concerned in environmental protection affairs.

20) **“Person”** means any natural or juridical person having legal personality.

- 5) Misoomni gaggeeffamu kamiyyuu fayyaa namaa yookiin naannoo irratti miidhaa geessisa jedhamee yoo amaname, miidhaa gahuu danda'u hambisuuf Biirron tarkaanfii akeekkachiisaa barreeffamaan yookiin hanga dhaabsisuu fi cufuu yookiin iddoo biraatti dabarsuuf gahu fudhachuu ni danda'a.

3. Gender Description

Provisions of this Proclamation set out in a masculine gender shall also apply to the feminine gender.

4. Scope of Implementation

This Proclamation shall be effective on all projects to be under taken in the National Regional State of Oromia.

PART TWO**ENVIRONMENTAL POLLUTION****5. Environmental Pollution Control**

- 1) No person shall pollute or cause any other person to pollute the environment by violating the relevant environmental standard.
- 2) The Bureau may take corrective measure against a person who contrary to the provisions of this Proclamation or and any other laws issued, releases any pollutant to the environment.
- 3) Any person engaged in any field of activity which is likely to cause pollution or any other environmental hazard shall, install a sound technology that avoids or reduces, to the required minimum, the generation of waste and, when feasible, apply methods for the recycling of waste.
- 4) Any person who causes any pollution shall be required to clean up the polluted environment within a limited period of time. When the government or other body cleans the environment, the person who causes pollution shall pay the cost of cleaning. The detail Shall be determined by the Regulation to be issued.
- 5) When any development activity believed to pose a risk to human health or to the environment, the Bureau shall take any necessary measure up to the closure or relocation of any enterprise in order to prevent harm.

6. Management of Hazardous Waste, Hazardous Chemical and Radioactive Substances

- 1) The generation, keeping, storage, transportation, make to transport or treatment or disposal of any hazardous waste without a permit from the Bureau or the competent body is prohibited.
- 2) Any person engaged in the collection, recycling, transportation, treatment or disposal of any hazardous waste shall take appropriate precaution to prevent any damage to the environment or to human health or well-being.
- 3) The mining, processing, distribution, storage, transportation or use of substances shall be subject to a permit from the competent body, and that may ensure by the Bureau.
- 4) The preparation, production, keeping, distribution, storage, transportation or use of a chemical categorized as hazardous or of restricted use, shall be subject to a permit from the Bureau or from other competent agency.
- 5) Any person engaged in the production, preparation, transportation or in trading in any hazardous or restricted chemical may ensure that the chemical is registered, packed, labeled as per the applicable standards and must check its expiration date.
- 6) Without the approval from the Bureau, whether the container of any hazardous waste is harmful or safe, selling, disposing, burning, giving to people or usage of these containers is prohibited.

- 4) Qaamni iddoo tajaajila bashannana ummataaf banaa ta'e bulchu kamiyyuu bakka kanatti manni fincaanii gahaa fi mijaa'aa ta'e, iddoo kuusaa gataa tajaajilaa barbaachisaa ta'an hunda guutuu qaba.

- 2) Biirron sirni qabiinsa gataa dhaabbatni diriirsu mijaa'aa fi ga'umsa kan qabu ta'uu isaa ni madaala, ni to'ata.
- 3) Bakki gataan dhaabbilee adda addaa itti gatamu naannoo ummatni iiraatu yookiin kuufama gataa kanaan wantoota miidhaan irra gahuu danda'u irraa fagaachuu qaba. Raawwiin isaa Danbiin kan murtaa'u ta'a.

7. Management of Municipal Waste

- 1) Urban administration shall have an integrated municipal waste management system.
- 2) The Bureau shall monitor and evaluate the adequacy of municipal waste management systems and ensure the effectiveness of their implementation.
- 3) The Bureau shall monitor the availability of waste disposal facilities at appropriate location by urban administrations.
- 4) Anybody responsible for the administration of the public recreation areas at all times shall, ensure that adequate and suitable toilets, containers and other required facilities are provided for the disposal of waste.

8. Organizations Waste Management

- 1) Any organization shall implement convenient and capable waste management systems.
- 2) The Bureau shall monitor and evaluate the implementation of convenient and capable waste management systems by organizations.
- 3) Waste disposal sites should be far from residential areas and anything that can be impacted by this waste disposal. Its implementation shall be determined by the regulation to be issued.
- 4) The Bureau, in collaboration with concerned body shall monitor organizations' waste management system.
- 5) Any organization shall have an obligation to dispose its waste on areas provided by the urban or district administrations.
- 6) Without prejudice to Sub-Article 5 of this Article, the convenience of the areas allotted for the waste disposal shall be ensured by the Bureau.

9. Noise Pollution

- 1) Any person shall not use an instrument that produces sound above permissible noise level that can harm human health and the environment.
- 2) No person shall be disturbed by the noise pollution that can harm his daily life.
- 3) A person or an organization is liable for the release of noise that can harm human health and the environment.
- 4) Any organization or factory releasing noise that can harm the health of employees shall have the responsibility to provide necessary protective devices to protect their well being.
- 5) The Bureau shall take any corrective measure up to closure of an organization releasing noise that can pose harm, as necessary based on study and set standard.

**PART THREE
LABORATORY AND
SETTING ENVIRONMENTAL
PROTECTION STANDARDS****10. Laboratory**

- 1) The Bureau must establish environmental laboratory in order to discharge its responsibilities in view of environmental protection and pollution control.
- 2) The Bureau shall provide technical assistance and make supervision to those factories in the region to have their own laboratory service.
- 3) The Bureau shall be liable for analytical test result error made in the laboratory.
- 4) The laboratory to be established will charge fair payment for service provision. Its implementation shall be determined by the Regulation to be issued.
- 5) The laboratory to be established shall be obligated to provide quality and standardized service.

- 6) Laaboraatorii keessatti qorannoon adeemsifamee bu'aan xiinxala ogummaan irra gahame seera duratti fudhatama ni qabaata.

 - (b) Sadarkaa qulqullina qilleensa naannoo fi hanga faaltotaa, madda socho'anii fi hin sochoone irraa gadi-lakkifaman kan ibsu;
 - (c) Sadarkaa akaakuu fi hanga wantoota biyyeetti dabalaman yookiin biyyee irratti yookiin biyyee keessatti gataman ibsu;

- 7) The laboratory staff are liable to have required work discipline while their delivering service.
- 8) The laboratory shall monitor and ensure the quality and standard of waste from municipal and different organizations by sampling at spot when necessary.

11. Environmental Protection Standards

- 1) Without prejudice to the environmental standards issued at national level, the Bureau may issue environmental standards based on the specific situation of the region for different areas.
- 2) According to this Article Sub Article 1, the environmental standards to be issued shall include at least the following:
 - (a) Standards for the discharge of effluents into water bodies and sewage systems;
 - (b) Air quality standards that specify the ambient air quality and give the allowable amounts of emission for both stationary and mobile air pollution sources;
 - (c) Standards for the types and amounts of substances that can be applied to the soil or be disposed of on or in it;
 - (d) Standards for noise providing for the maximum allowable noise level taking into account the settlement patterns and the availability of scientific and technological capacity in the country;
 - (e) Waste management standards specifying the levels allowed and the methods to be used in the generation, handling, storage, treatment, transport and disposal of the various types of waste.

PART FOUR ENVIRONMENTAL INSPECTORS

12. Environmental Inspectors

- 1) Environmental inspectors shall be designated by the Bureau.
- 2) Environmental inspectors shall exercise due diligence and impartiality in discharging of their powers and duties.

13. Powers and Duties of Inspectors

Environmental inspectors shall have the following powers and duties:

- 1) Monitor compliance with environmental standards and related requirements;
- 2) Inspectors shall have an identity card issued by the Bureau, and show it when requested;
- 3) When inspectors on duty visit an undertaking of any organization, they shall notify the proprietor or the manager or the representative of the organization;
- 4) Without prejudice to Sub-Article 3 of this Article, when inspector consider that such notification may hinder his performance, enter any land or premises at any time which seems appropriate to him without prior notice or court order;
- 5) Obtain information, check or copy or extract any paper from file or record or any other documents related to pollution;
- 6) Without prejudice to Sub-Article 5 of this Article, the inspectors shall keep the information obtained confidentially and take necessary care not to use for other purpose;
- 7) The inspectors while inspecting any organization can write their comments on comment record. In the absence of comment record, they shall send written comments within two days;

- 2) To'ataan eegumsa naannoo yeroo hojii isaa hojjetu mooraa isaa banuun saamuda, odeeffannoo fi ragaalee barbaachisaa ta'an kennuu, akkasumas oomishaa fi adeemsaalee oomishaa agarsiisuuf hayyamamaa ta'uu qaba;

9) Take photographs, measure, draw, or examine any commodity, process or facility in order to ensure compliance with this Proclamation and with any other relevant law;

10) When a person contravenes any of the provisions of this Proclamation or of any other relevant laws, the inspectors on duty shall specify the matter constituting the contravention and may also specify the measures that shall be taken to remedy the contravention within a given period of time;

11) When inspectors on duty suspect that any activity may cause damage to the environment, they shall order the taking of corrective measures up to the immediate discontinuation of the activity;

12) Whenever a sample is to be taken, the proprietor has the right to be present or to send his representative.

14. The Obligation of the Proprietor and Organization

Any proprietor or organization shall have the following obligations:

- 1) The Inspector shall prepare comment record books on which the environmental inspectors write their comments or give orders during their inspection;
- 2) The Inspector have to be willing by opening their door when inspectors performing their activity to take samples, by providing the necessary information as well as showing production and production processes;
- 3) The proprietor or organization shall materialize the comments given by the inspectors;

- 4) Wantootaa hamaa naannootti gadi-lakkisuu hin qaban;

- 2) Guyyaa komiin dhiyaate irraa eegalee guyyoota hojii shan keessatti Biiron murtii kennuu qaba.
- 3) Akkaataa Keewwata kana Keewwata Xiqqaa 2 jalatti tumameen murtiin kan hin kennamne yoo ta'e yookiin murtii kenname irratti komiin yoo jiraate, guyyaa murtiin itti kenname yookiin murtiin itti kennamuu qabu irraa eegalee guyyoota soddama keessatti iyyata isaa Mana Murtiitti dhiyeeffachuu ni danda'a.

- 4) The proprietor or organization shall not release hazardous materials to the environment;

15. Submitting a Complaint

- 1) Any person dissatisfied with the measures taken by the inspectors may submit his complaint to the Bureau within ten working days from the date on which the measure was taken.
- 2) The Bureau shall give decision within five working days from the date of the acceptance of the complaint.
- 3) Where no decision has been given as per Sub-Article 2 of this Article, or there is a complaint against a given decision, any person may submit the case to a court within thirty days from the date on which the decision was given or supposed to be given.

16. Incentives

Incentives shall be given for the introduction of methods that enable the prevention or minimization of pollution in any existing undertaking. Its implementation shall be determined by the Regulation to be issued.

17. Tip-off

- 1) Any person shall have, the duty to inform the Bureau against anybody allegedly causing actual or potential damage to the environment.
- 2) When the Bureau fails to give a decision within fifteen days of the acceptance of the tip-off or the person who has tipped-off is dissatisfied with the decision, may submit the case to the court with in sixty days from the date the decision was given, or was supposed to be given.
- 3) A person who tips-off is not obligated to give his name and address. The information he gave shall be kept confidential.

PART FIVE

OFFENCES AND PENALTIES

18. Offences Relating to Organizations

A person commits an offence if he hinders or obstructs inspectors on duty in the execution of their duty, fails to comply with a lawful order or requirement made by inspectors, or refuses entry into any land or premise or hinders from getting access to records, prevents from copying or extracting any paper, file or any other document, withholds, misleads or gives wrong information to inspectors.

- 1) A natural person who commits an offence is liable, on conviction, to a fine of not less than three thousand Birr and not exceeding ten thousand Birr.
- 2) In case of a legal person, to a fine of not less than ten thousand Birr and not exceeding twenty thousand Birr.
- 3) Imprisonment of the officer in charge for a term of not less than one year and not exceeding two years or a fine of not less than five thousand Birr and not exceeding ten thousand Birr or both.

19. Offences Relating to Heads and Inspectors

Bureau heads or environmental inspectors at different levels when benefited or made benefit others by using power illegally or provide wrong data or made others provide wrong data or give decision based on wrong data or dismisses data, shall be imprisoned for a term of not less than three years and not exceeding eight years, or a fine of not less than fifteen thousand Birr and not exceeding thirty thousand Birr.

20. Badiiwan Galmeen Walqabatanii fi Adabbii

20. Offences Relating to Records & Penalty

A person commits an offence if he fails to keep records of activities or products or the types and characteristics of waste or of any other information, or if he alters any record shall be liable, on conviction, to a fine of not less than ten thousand Birr and not exceeding twenty thousand Birr.

21. Offences Relating to Pollutants, Hazardous Wastes and Materials

Unless and otherwise penalizes mo by criminal code, a person commits an offence if he fails to manage a hazardous waste or another substance according to this Proclamation and the relevant laws, mislabels or fails to label or in any way withholds information about any hazardous waste or other material or attempts to take part or takes part or attempts to aid or aids in the illegal traffic of any hazardous waste or other material:

- 1) A natural person who commits an offence is liable, on conviction, to a fine of not less than twenty thousand Birr and not exceeding fifty thousand Birr.
- 2) In the case of a legal person to a fine of not less than fifty thousand Birr and not exceeding one hundred thousand Birr.
- 3) Imprisonment of the manager in charge of not less than three years and not exceeding six years, or a fine of not less than thirty thousand Birr and not exceeding seventy thousand Birr or both.

22. Offences Relating to Pollutants

- 1) A natural person commits an offence if he discharges any pollutant contrary to the provisions of this Proclamation is liable, on conviction, to a fine of not less than one thousand Birr and not exceeding five thousand Birr or to an imprisonment of not less than one year and not exceeding ten years or both.
- 2) In the case of a legal person, to a fine of not less than five thousand Birr and not exceeding twenty five thousand Birr.
- 3) Imprisonment of the manager in charge for a term of not less than five years and not exceeding ten years, or a fine of not less than five thousand Birr and not exceeding ten thousand Birr or both.

23. Forfeiture and Restoration

The court, before which a person is prosecuted for an offence under this may, in addition to any penalty it impose upon the convicted person, order:

- 1) The confiscation of anything used in the commission of the offence in favor of the state or to dispose of it in any other way;
- 2) That the cost of cleaning up and the disposing of the substance and chemical or equipment seized be borne by the convicted person; and
- 3) The convicted person to restore to the state in which the environment was prior to the infliction of the damage, and when such restoration is not possible to pay appropriate compensation.

28. Seerota Raawwatiinsa Hin Qabaanne

Seerotaa fi hojimaanni dhimma Labsii kana haguugamaniin wal-faallessan kamiyyuu raawwatiinsa hin qabaatan.

29. Yeroo Labsiin Kun Hojii Irra Itti Oolu

PART SIX MISCELLANEOUS PROVISIONS

24. Relations with Neighboring Regions and Cities

- 1) The Bureau shall work in collaboration with neighboring regions to halt the spreading of environmental pollution from Oromia Region to neighbor regions and from neighboring regions to Oromia.
- 2) The Bureau shall work in collaboration with Addis Ababa City Administration based on laws and directives issued to control environmental pollution and wastes released from Addis Ababa City Administration.

25. The Obligation of Stakeholders

Any stakeholder in the region concerned in environmental protection shall cooperate, present their plan and report to the Bureau to control or minimize environmental pollution.

26. Duty to Provide Information

Any person engaged in an activity pertaining to any of the provisions of this Proclamation or any other related law shall provide any information on his activity as required by the Bureau.

27. Power to Issue Regulations

The Administrative council of the Region shall have the power to issue Regulations for implementing this Proclamation.

28. Inapplicable Laws

Any law or practice inconsistent with this Proclamation is inapplicable on matters provided herein.

29. Effective Date

This Proclamation shall come into force as of the 1st day of December, 2012.
