A Proclamation to Establish the Town Administration in the Oromia Regional State

Whereas, it has become necessary to strengthen the administration of towns in the Oromia Regional State so as to enable them provide full social and economic services for their residents;

Whereas, based on their level of development, it has become necessary to categorize the towns according to their levels and clearly determine their powers and duties; Now, therefore, in accordance with articles 45 and 49 (3)(a) of the Constitution of the Oromia Regional State, it is hereby proclaimed as follows.

- Mata Duree Gabaabaa**
Labsiin kun "Labsii Mootummaa Naannoo Oromiyaatti Bulchiinsa Magaalaa dhaabuuf bahe lakk.26/1991" jedhamee waamamu ni dandaa.
- Hiika**
Akkaataan jechichaa hiika biraa kan kennisiisuuf yoo ta'e malee Labsii kana keessatti:
1. "Mootummaa" jechuun Mootummaa Naannoo Oromiyaati.
 2. "Ministeera" jechuun Ministera Hojii fi Misooma Magaalaa Mootummaa Federaalati.
 3. "Biiroo" jechuun Biiroo Hojii fi Misooma Magaalaa Oromiyaati.
 4. "Magaalaa" jechuun armadura kan manni qopheessaa keessatti dhaabate yookaan Biiroon qaama dhimmi isa ilaaluu wajjin mari'achuudhaan akkaataa ulaagaa Ministerichi baasuun magaalaa jedhee kan moggaasuudha.
 5. "Bulchiinsa magaalaa" jechuun ulaagaa Ministerichi baasurratii hundaa'uudhaan Mootummaadhaan sadarkaan magaalaa kan kennameef bulchiinsa keessaati.
 6. "Nama" jechuun nama uumamaa yookaan qaama seeraan namummaan kennameefiidha.
 7. "Ittaanaa Aanaa" jechuun sadarkaa bulchiinsa magaalaa Aanaa Addaa gadii fi bulchiinsa magaalaa Ganda Addaati ol ta'ee magaalaa ganda tokkoo ol qabu keessatti bulchiinsa magaalaa dhaabateedha.
 8. "Qabeenya xifaafiree" jechuun beellada yookaan qabeenya biraa kan abbaa hinqabne yookaan abbaa otoo qabuu waan hin eegaminiif iddoo bulchiinsi magaalaa tajaajila uummat-aaf ramade keessatti argameedha.

 1. Bulchiinsi magaalota Naannoo Oromiyaa akkaataa Labsii kanaan sadarkaa afuritti hiramuu.

፯/ «ጠፍ ንብረት» ማለት ባለቤት የሌለው ወይም ባለቤት እያለው ባለ መጠበቁ ምክንያት የከተማ አስተዳደር ለሕዝብ አገልግሎት በመደበው ሥፍራ ውስጥ የተገኘ እንስሳ ወይም ሌላ ዓይነት ንብረት ነው።

፰/ «ምክትል ወረዳ» ማለት ከልዩ ወረዳ የከተማ አስተዳደር ደረጃ በታችና ከልዩ ቀበሌ የከተማ አስተዳደር ደረጃ በላይ ሆኖ ከአንድ ቀበሌ በላይ ባላቸው ከተሞች የተቋቋመ የከተማ አስተዳደር ነው።

፩. በዚህ አዋጅ መሠረት የከልላዊ ከተሞች በአራት ደረጃዎች ይመደባሉ።

1. Short Title

This Proclamation may be cited as the "Establishment of Town Administration in the Oromia Regional State Proclamation No. 26/1999."

2. Definitions

In this Proclamation, unless the context otherwise requires:

1. "Government" means the Oromia Regional Government.

2. "Ministry" means the Ministry of Works and Urban Development of the Federal Democratic Republic of Ethiopia.

3. "Bureau" means the Oromia Bureau of Works and Urban Development

4. "Town" means a place in which municipality has already been established or which is designated as town by the Bureau in consultation with the Ministry.

5. "Town Administration" means an internal administration given to a town graded as such by the Government based on the directives to be issued by the Ministry.

6. "Person" means any natural or juridical person.

7. "Astray animal or lost property" means any animal or other property without owner or any animal wandering at large in public places designated as such by the municipality.

8. "Sub-Woreda" means a town whose status is below the level of a special woreda town but higher than a special kebele town and consisting of more than one kebele.

3. Levels of Town Administration

1. In accordance with this Proclamation, towns in the Oromia Region shall be classified into four levels.

2. Akkaataa keewwata kana (1) tiin guddina magaalichaarratti hundaa'ee sadarkaan kennamus sadarkaa Godina Addaa, yookaan Aanaa Addaa, yookaan Ittanaa Aanaa yookaan Ganda Addaa ta'u ni danda'a.
3. Akkaataa keewwata kana (1) tiin sadarkaan bulchiinsa magaalotaa, baa'innii fi daangeffamni gandoota magaalaa qajeelfama Koreen Hojii Raawwachiiftuu Mootummaa baasuun murtaa'a.
4. *Qaamolee bulchiinsa magaalaa*
 1. Bulchiinsi magaalaa sadarkaa kamittuu dhaabatu qaamolee kanatti aananii ibsaman ni qabaata:
 - a) Mana Maree fi
 - b) Koree Hojii Raawwachiiftuu.
 2. Keewwata kana (1) jalatti kan ibsame akkuma jirutti ta'ee, bulchiinsi magaalaa Godina Addaa fi Aanaa Addaa barbaachisummaan isaa Koree Hojii Raawwachiiftuu Mootummaatiin yoo murtaa'e, qaama abbaa seerummaa, mana hojii abbaa alangaa, waajjira nageenyaa fi poolisii qabaachuu ni danda'u.
 3. Qaamoleen keewwata kana (2) jalatti ibsaman hanga hundeeffamanitti hojiin akkaataa armaan dura hojjatamaa tureen itti fufa.
5. *Aangoo fi hojii bulchiinsa magaalaa Godina Addaa*
 1. Bulchiinsi magaalaa sadarkaa Godina Addaatti dhaabate aangoo fi hojiwwan seeraan Godina biraatiif kenname akka barbaachisaa ta'etti magaalicha keessatti ni qabaata.
 2. Keewwata kana (1) jalatti kan ibsame jiraatullee Godinichi Addaa:
 - a) Wixinee seera kiraa lafaa, taaksii tajaajilaa, gibira manneenii fi taarifa galii adda addaa qoratee koree Hojii Raawwachiiftuu Mootummaatti ni dhi'eessa; yoo mirkanaaye ni sassaaba;

ለ/ የሥራ አስፈጻሚ ኮሚቴ።

፪. በዚህ አንቀጽ ንዑስ አንቀጽ /፩/ ሥር የተገለፀው እንደተጠበቀ ሆኖ፣ አስፈላጊነቱ በክልሉ መንግሥት የሥራ አስፈጻሚ ኮሚቴ ከታመነበት በላይ ዞን እና ልዩ ወረዳ የከተማ አስተዳደር የዳኝነት አካል፣ የዐቃቤ ሕግ መሥሪያ ቤት እና የፀጥታና የፖሊስ ጽ/ቤት ሊቋቋሙ ይችላሉ።

፫. በዚህ አንቀጽ ንዑስ አንቀጽ /፪/ የተገለጹት አካላት እስኪቋቋሙ ድረስ ከዚህ ቀደም እነዚህን ተግባራት ሲያከናውኑ የነበሩት መሥሪያ ቤቶች ሥራቸውን ይቀጥላሉ።

፬. የልዩ ዞን ከተማ አስተዳደር ሥልጣንና ተግባር

፩. በልዩ ዞን ደረጃ የተቋቋመ የከተማ አስተዳደር ለሌላ ዞን መስተዳደር በሕግ የተሰጠው ሥልጣንና ተግባር እንዳስፈላጊነቱ በተቋቋመበት ከተማ ውስጥ ይኖረዋል።

፪. በዚህ አንቀጽ ንዑስ አንቀጽ /፩/ የተገለጸው ቢኖርም የልዩ ዞን ከተማ አስተዳደር፡-

ሀ/ የቦታ ኪራይ፣ የአገልግሎት ታክስ፣ የቤት ግብርና የልዩ ልዩ ገቢዎች ታሪፍ ደንብ ረቂቅ አጥንቶ ለክልሉ መንግሥት ሥራ አስፈጻሚ ኮሚቴ ያቀርባል፤ ሲጸድቅም ይሰበስባል፤

2. Pursuant to Sub-Article (1) of this Article, a town may be classified as a special zone, or special woreda or sub-Woreda or special kebele.

3. In accordance with Sub-Article (1) of this Article, the levels of town administration, number of Kebeles and their delimitations shall be determined by the directives to be issued by the Executive Committee of the Government.

4. Organs of Town Administration

1. Town administration established at any level shall have the following organs:

- a) A Council and
- b) An Executive Committee

2. Without prejudice to sub-article (1) of this Article, where the Executive Committee of the Government deems it necessary, judicial organs, offices of prosecutors and the police may be established in special zone and special woreda towns.

3. Until the organs specified under sub-article (2) of this Article are established, the organs up to now performing the functions shall continue.

5. Powers and Duties of Special Zone Town Administration

1) A special zone town administration shall have the same powers and duties given to the other zone administration by law.

2) Notwithstanding the provisions of Sub-Article (1) of this Article, the Special Zone town administration shall have the following powers and duties.

- a) to prepare and submit regulations to the Executive Committee of the Government pertaining to urban land rent, service charges, urban house tax and other charges and upon approval, collect same;

- b) Pilaanii magaalichaa Biiroodhaan ykn qaama biraatiin qoratamee koree Hojii Raawwach-iiftuu Mootummaatiin mirkan-aa'ee eergamuuf hojiiirra akka oolu ni taasisa;
- c) Akkaataa pilaanii magaalichaa, seeraa fi qajeelfama itti fayyadama lafa magaalatiin ijaarsi akka adeemsifamu ni eeyyama;
- d) Ijaarsi seeraan ala akka hin adeemsifamne ni to'ata; kan ijaaramee nama ijaaren yookaan baasii fi kisaaraa nama ijaareetiin akka diigamu ni taasisa;
- e) Qaama dhimmi ilaalu waliin ta'uudhaan daandiiwwan, waltajjiiwwan, riqichoota, iddoowwan haaragalfannaa fi bashannanaa, magartuuwwan, hojiiwan uummataaf faayidaa kennan kan akka bishaanii, ibsaa, iddoowwan gabaa guguddaa, mana qalma beelladaa, mana dhiqannaa uummataa, galma walgahii uummataafi tiyaati-raa, manneen barnootaa fi kkf magaalicha keessatti akkuma barbaachisummaa isaaniitti ni hojjeta, yookaan akka hojjetaman ni taasisa; ni qindeessa, ni eega;
- f) Istandardii Biiron baasuratti hundaa'uudhaan hanqina mana jireenyaa salphisuudhaaf manneen qusannaa ijaaree ni kireessa;
- g) Tajaajila ittisa balaa ibiddaa, ambulaansii fi qulqulinaa ni qixoomsa; ni to'ata;
- h) Qulqullina magaalichaa ilaalchisee tarkaanfii barbaachisaa ta'e ni fudhata;
- i) Akkaataa seera fi qajeelfama qaamni dhimmi isa ilaalu baasuun naannowwan magaalichaa keessatti kan argaman:
- Bosonni siriitti eegamuu fi misoomuu isaa;
 - Albuudni akka dhagaa, cirrachaa fi kkf siriitti eegamuu isaanii ni to'ata.
 - Hojii namni kamiyyuu hojjetu nagaafi fayyaa uummatichaarratti akkasumas eegumsa naannoo kan hin faallesine ta'uu isaa ni mirkanessa; ni to'ata;

b) to implement the approved plan of the town which is prepared and submitted of the Executive committee of the Government by the Bureau or another organ;

c) in accordance with the plan of the town and laws pertaining to urban land to issue construction permits;

d) to control illegal construction; to cause its demolition by the person who constructed it, or demolish it by the expenses to be covered by the person who constructed it;

e) in collaboration with the concerned body, to construct or cause to be constructed and maintain streets, squares, bridges, resorts, parks, public gardens, and public utilities such as water, electric light, grand market places, slaughter houses, public baths, public halls, theatres, schools and the like;

f) in accordance with the standard plan to be issued by the Bureau, to construct and rent low cost dwelling houses to alleviate shortages;

g) to organize and supervise fire protection, ambulances and sanitary services.

h) to take appropriate measures to ensure the cleanness of the town,

i) in accordance with the laws and directives issued by the appropriate body, to ensure in the town:

(a) the proper protection and development of forests;

(b) the protection of quarries, sand and other similar materials;

j) to ascertain and control that any work done in the town is not contrary to the requirements of public health safety and the environment;

- k) Qabeenya yookaan beellada xifaafiree magaalicha keessatti argamu ni eegsisaa; abbaan isaa yeroo seeraan murtaa'e keessatti yoo dhi'aate, kafaltii barbaachisaa kafalchiisee har-kaan ni gaha; yoo dhi'aachuu baate akkaataa seeraatiin tar-kaanfii barbaachisaa ta'e ni fudhata;
- l) Hojiiwwan tajaajila hawwaasaa fi misooma dinagdee mootummaadhaan magaalicha keessatti hojjetamuuf karoofaman, akkasumas imaammani, seerrii fi qajeelfamni mootummaan baasu hojjiirra ooluu isaanii ni hordofa; ni to'ata;
- m) Jiraattota magaalichaa bal'inaan hojii misoomaaf ni kakaa-sa; hojiiwwan misoomaa gandoota magaalichaan hojjeta-man ni qindeessa; ni to'ata; akka barbaachisummaa isaa-tti deggersa ogummaa ni ken-na;
- n) Biiroo wajjin mari'achuudhaan baajataafi karoora wag-gaa qopheessee Mana Maree bulchiinsa magaalichaatiif ni dhiheessa; yoo mirkanaa'e hoji-irra ni oolcha;
- o) Hojiiwwan biraa kennamaniif ni raawwata.

n) in consultation with the Bureau, to prepare and submit to the town council plans and annual budget the town and implements same upon approval;

o) to perform other functions assigned to it.

6. Powers and Duties of the Special woreda, Sub-woreda and Special kebele

1. A Special Woreda:

a) Shall have the powers and duties given to the other Woreda administration by law;

b) Without prejudice of the provisions of Sub-Article (1) (a) of this Article, shall prepare and submit draft law pertaining to urban land rent, service charges, urban house tax and other sources of revenues to be passed through the zonal administration to the Executive Committee of the Government for approval.

2. A sub-Woreda town administration shall have the power to organize and supervise the functions assigned to kebeles by law.

3. A Special kebele shall have the powers and duties given to another kebele by law.

b) to prepare work programs and directives which facilitate the proper implementation of the functions assigned to the town administration;

c) to give decisions on certain day to day activities of the town administration and supervise their execution.

2. The executive committee members shall be collectively accountable to the council for the duties they have executed in common and to the executive committee for the functions performed by the members individually.

11 Powers and Duties of the Executive Committee members

1. The Chairman of the Executive Committee shall be accountable to the council and executive committee and shall have the following powers and duties:

a) to convene and preside over the meetings of the council;

b) to exercise the powers and duties given to the chairman of the executive committee of zone administration or woreda or kebele assembly by law as the case may be;

- c) Dura taa'aan Godina Addaa walgahii Caffee Mootummaa Oromiyaa irratti ni hirmaata;

2. The Vice-chairman shall be accountable to the executive committee and chairman of the town and shall:
- a) carry out the duties of the chairman in the absence of the latter;
- b) perform the duties assigned to him by the executive committee and chairman.
3. The Secretary shall be accountable to the executive committee and the chairman and shall;
- a) perform the duties of the chairman and vice-chairman in their absence;
- b) organize the office of the council;
- c) keep properly the documents of the executive committee;
- d) keep the minutes of the council and executive committee;
- e) direct secretarial works of the council;
- f) perform such other functions assigned to them by the executive committee or chairman.
4. Other members of the committee shall perform the functions assigned to them by the Executive Committee.
12. *Disciplinary Matters*
1. The disciplinary matters of the members of the Council and Executive Committee shall be determined by the directives to be issued by the Executive Committee of the government.

2. Disciplinary matters of the employees of the town administration shall be determined in accordance with the civil service laws and directives.

13. Remuneration

1. Based on the directives to be issued by the Executive Committee of the Government, the town administration shall pay salary and other benefits to the executive committee members mentioned under Article 9(3) (a-d).

2. Other Executive members who are not included under Sub-Article (1) of this Article shall be paid allowance for meeting days.

14. Other Towns

Without prejudice to the powers and duties assigned to the kebele administration by other laws, towns which are given juridical personality but not yet assumed a status of town administration shall have the following powers and duties:

- 1) to carry out the functions given to town administration except those mentioned under Article 5(1) and (2), (a)(n) and (i);
- 2) to collect urban land rent, urban house rent and service charges;
- 3) based on the assistance given by the Bureau, to prepare annual budget and programs to be submitted to the executive committee of the Woreda council and implement same upon approval.

15. Transfer of Powers and Duties

The rights and obligations of a municipality shall be transferred to the concerned town administration.

- 1) for a special zone by the Executive committee of the Regional government;
- 2) For a special woreda or sub-woreda by the Executive Committee of the zone administration,
- 3) for a special kebele by the executive committee of the Woreda Council,

17. *Power to Issue Regulations*

The Oromia Regional State Executive Committee may issue regulations for the proper implementation of this Proclamation.

18. *Inapplicable laws*

Any law, regulations or directives which are inconsistent with this Proclamation shall have no effect with respect to matters provided for in this Proclamation.

19. *Effective Date*

This Proclamation shall enter into force on the date of its publication in the Megelete Oromia.
