2. Definitions

In this Proclamation:

1. "Board" means the Board of the Irrigation Development Authority of the Oromia Regional State.
2. "Council" means the Oromia Regional State Council.
3. "Beneficiary" means any person or organization that benefits from the irrigation development scheme.
4. "Executive Committee" means the Executive committee of the Oromia Regional State.
5. "Irrigation Development" means the construction of river diversions, dams, farm structure and other related irrigation construction works.
6. "Government" means the Oromia Regional Government.
7. "Region" means the Oromia Region.

3. Establishment.
The Oromia Regional State Irrigation Development Authority (hereinafter referred to as "the Authority") is hereby established as an autonomous organ of the Regional Government.

4. Objectives

The Authority shall have the following objectives:

1. To undertake the study, design and construction works of irrigation schemes in suitable areas of the Region in order to secure food self-sufficiency.
2. To contribute towards hastening the socio-economic development of the agrarian community.
3. To enable the community to participate, in the study, construction and administration of irrigation projects and benefit from them.

5. Head Office

The Authority shall have its head office in Finfinne and may establish branch offices as may be necessary.

6. Powers and Duties of The Authority
The Authority shall have the following powers and duties:

1. Initiate and submit policies, strategies, laws and regulations related to the authority's functions to the Executive Committee and implement the same upon approval;

1. “Militia” means a person who is elected by the community to keep the security of same without any payment and without being isolated from his production activities.
 2. “Region” means the Oromia Region.
 3. “State” means the Oromia Regional State.
 4. “Executive Committee” means the Executive Committee of the Oromia Regional State.
 5. “Person” means a physical or juridical person.
3. **Establishment**
The Oromia Militia Office (hereinafter referred to as the “Office”) is hereby established by this Proclamation.
4. **Objectives of the Office**
The Office shall have the following objectives:
1. To protect and cause to observe the rights and benefits, peace and security of the people of the Region as enshrined in the Constitutions of the Federal Democratic Republic of Ethiopia and Oromia Regional State, and
 2. To defend forces which try to snatch forcibly the rights and benefits of the people.
5. **Organization of the Office**
1. The Office shall have structures at Regional, Zonal, and Wereda levels.
 2. Notwithstanding the provisions of sub-article (1) of this Article, the Office shall have certain unit of forces below the Wereda level.
6. **Accountability of the Office and its branches**
1. The Office shall be accountable to the Executive Committee.
 2. The Zonal branch office shall be accountable to the Regional Office and the Zonal executive committee; whereas the Wereda branch office shall be accountable to the Zonal Office and the wereda executive committee.
 3. The unit of forces organized below the Wereda shall be accountable to the Wereda Office and the Kebele executive committee.

5. Deggersa Humna Poolisiin kennamu bakka argachuun hindanda' amnetti, manneen murtii idilee fi manneen murtii hawwasummaatiif deggersa ni godha;
6. Koree hojii raawwachiiftuun yeroo murtaa'u Milishaan humna Ittisa Biyyoolessaa waliin akka bobba'u ni taasisa;
7. Karooraa fi baajata qopheesse Mootummaa Nannootiif ni dhiheessa; yammuu heyya-mamu hojii irra ni oolcha.

8. *Aangoo fi Hojii Hogganaa Waajjirichaa*

Hogganaan Waajjirichaa keewwata 7 jalatti hojiiwwan waajjirichaa kennaman ni raawwata; dabala-taanis:

1. Waajjiricha bakka ni bu'a; ni qajeelcha; seeraa fi qajeelfama irratti hundaa'ee wajjirichaa fi dameewwan wajjirichaa ni bulcha;
2. Sochii hojii waajjirichaa ilaalchiisee gabaasa yeroo yeroon koree hojii raawwachiiftuuf ni dhiheessa;
3. Hojiiwwan biroo koree hojii raawwachiiftuun kennamaniif ni raawwata.

7. *Powers and Duties of the Office*

The Office shall have the following powers and duties:

1. To organize and direct the militia Offices and units of forces established at different levels;
2. To recruit, train, organize, arm and mobilize the militia members in accordance with the directives issued by the Government;
3. To prevent and follow-up the commission of crimes in collaboration with other security forces of the Region;
4. Unless otherwise instructed by an appropriate organ, to follow-up and control that a militia member may not take part in security and other functions in a manner affecting his production activities;
5. In a place where the police force is not available, to assist regular courts and social courts;
6. Where decided by the Executive Committee, to cause the militia to work with the National Defense Force;
7. To prepare and submit its plan and budget to the Government and implement same upon approval.

8. *Powers and Duties of the Head of the Office*

The Head of the Office shall carryout the functions given to the Office under Article 7; besides he shall:

1. represent and direct the Office and branch offices according to the relevant laws and directives;
2. submit periodic reports regarding the activities of the Office to the Executive Committee;
3. carryout other functions given to him by the Executive Committee.

9. *Recruitment and Accountability of Militia*

1. A militia shall be recruited by a direct participation of the community.
2. Any person who:

5. The rights and duties of the Militia which are not provided for under this Proclamation shall be determined in the directives to be issued.

10. Powers and Duties of the Militia

Any militia member shall:

1. follow-up and prevent commission of crimes in collaboration with other security forces and the community;

2. immediately hand over a person caught red-handed or an exhibit to the nearest police station and report the details of the crime;

3. organize the community and arrest bandits or thieves or other criminals who break the law;

4. collaborate with the defense force as mentioned under sub-article (6) of Article 7;

5. carryout other functions given to him by the Office.

11. Arms

1. Any militia member shall use the arm given to him for lawful purpose.

2. Any militia member shall be held responsible where he sells or otherwise transfers to another person or damages the arm given to him by the Government.

12. Budget

The budget of the Office shall be allocated by the Government.

13. Duty to Cooperate

Any person shall have a duty to cooperate for the implementation of the provisions of this Proclamation.

14. Penalties

A person who violates the Proclamation or regulations or directives to be issued in accordance with this Proclamation shall be punishable in accordance with the relevant provisions of the Penal Code.

15. Inapplicable Laws

Any regulation or directive or practice inconsistent with this Proclamation shall not be applicable with respect to matters provided for in this Proclamation.

16. Former Militia Members

Without prejudice to sub-article (2) of Article 9, the militia members who have been elected prior to the effective date of this Proclamation and rendering service in the Region shall be considered to have been elected in accordance with this Proclamation and continue giving the service.

17. Issuance of Regulations

The Executive Committee may issue regulations for the effective implementation of this Proclamation.

18. Effective Date

This Proclamation shall enter into force as of the 13th day of March, 2000.
