1. "Mootummaa Naannoo" jechuun Mootummaa Naannoo Oromiyaatii.
2. "koree Hojii Raawwachiiftuu" jechuun Koree Hojii Raawwachiiftuu Mootummaa Naannoo Oromiyaatii.
3. "Boordii" jechuun Labsii kanaan kan hundeeffame Instituu-tii Manajimantii Oromiyaa qaama gaggeessu dha.
3. **Hundeeffama**
 1. Inistituutiin Manajimantii Oromiyaa (kana booda "Inistituutii" jedhamee kan waamamu) Labsii kanaan hundeeffameera.
 2. Inistituutichi itti waamamni isaa Boordiidhaafi koree Hojii Raawwachiiftuuf ni ta'a.
4. **Mummicha Wajjirichaa**
Mummicha Waajjira Inistituutichaa Koree Hojii Raawwachiiftuun ni murtaawa.
5. **Kaayyoo**
Inistituutichi kaayyoowwan armaan gadii ni qabaata:
 1. Leenjii Manajimantii Naannichaa keessatti adeemsifamu seera qabsissuufi leenjii fedhii Naannichaa irratti hundaa'e hordofuuf kan dandeessisu tooftaa uumuu;
 2. Humna namaa sadarkaa hundaa Naannichaa keessatti bobba'ee jiru dandeettii orggan-tummaa isaa cimsuuf leenjii barbaachisaa tahe kennuufi woorkshoopii adeemsiissuu.

1. "Regional State" means the Oromia Regional State.
2. "Executive Committee" means the Executive Committee of the Oromia Regional State.
3. "Board" means a body that oversees the activities of the Oromia Management Institute established by this Proclamation.
3. **Establishment**
 1. The Oromia Management Institute (hereinafter referred to as the "Institute") is established by this Proclamation.
 2. The Institute shall be accountable to the Executive Committee and the Board.
4. **Head Office**
The Head Office of the Institute shall be determined by the Executive Committee.
5. **Objective**
The Institute shall have the following objectives:
 1. Devise a method that shall enable to systematize the management training conducted in the Region and to conduct the training based on the need of the Region;
 2. Give training and conduct workshops to develop management efficiency of the manpower of the Region engaged at all levels.
6. **Powers and Duties of the Institute**
The Institute shall have the following powers and duties:
 1. Undertake training need study with the view to developing management efficiency of the Regional State organs;
 2. Prepare and give short, medium and long-term trainings with the view to developing and upgrading management efficiency of all the Regional State management bodies;
 3. Give the necessary management training so that public servants of the Region shall be able to discharge their duties efficiently;
 4. Collect useful management training information and make it combined with the social, economic and political plan of the Region;
 5. Formulate strategy concerning the ways and means of obtaining funds needed for conducting management training;

6. Grant certificates to trainees;
 7. Render management consultancy services in line with the decision of the Board;
 8. Establish work relation with concerned institutes in order to get assistance of professionals;
 9. Perform such other functions that shall assist to achieve its objectives.
7. *Organization of the Institute*
The Institute shall have:
- (a) a Board,
 - (b) a Director who shall be appointed by the Executive Committee, upon recommendation of the Board, and
 - (c) the necessary staff.
8. *Members of the Board*
The Board shall have a chairperson and members whose number shall be from five to seven. They shall be appointed by the Executive Committee upon presentation by the President of the Regional State.
9. *Powers and Duties of the Board*
The board shall have the following powers and duties:
1. Direct the activity of the Institute;
 2. Prepare and submit to the Executive Committee of the short, medium and long-term plan, work program and budget of the Institute and follow-up the implementation of same;
 3. Elect and present to the Executive Committee for appointment the Director who directs the Institute;
 4. Appoint heads of departments, upon presentation by the Director;
 5. Without prejudice to Article 12(2)(b), issue directives;
 6. Follow-up in order to ensure that the property and books of accounts of the Institute are properly handled;
 7. Evaluate activity performance of the Institute and submit its report to the Executive Committee;
 8. Perform such other functions as may be assigned to it by the Executive committee.
10. *Accountability of the Board*
The Board shall be accountable to the President of the Regional State and Executive Committee.

11. Meeting of the Board

1. The Board shall meet once in three months.
2. There shall be a quorum where more than half of the members of the Board are present.
3. Decision of the Board shall be made by a majority vote; in case of tie, the chairperson shall have a casting vote.

12. Powers and Duties of the Director

The Director shall be accountable to the Board and shall have the following powers and duties:

1. Implement the powers and duties vested in the Institute under Article 6 of this Proclamation.
2. Without prejudice to sub-article (1) of this Article, the Director shall have the following powers and duties:
 - (a) Direct the activities of the Institute in accordance with the guidelines issued by the Board;
 - (b) Employ, administer and dismiss necessary personnel for the Institute in line with the directives approved by the Executive Committee;
 - (c) Prepare and submit to the Board the plan, work program and budget of the Institute;
 - (d) Spend money in line with the work program and budget approved for the Institute;
 - (e) Establish working relations with other organs on behalf of the Institute;
 - (f) Prepare and submit to the Board the activity and financial report of the Institute;
 - (g) Perform such other functions as may be assigned to him by the Board.
3. Delegate other officials and employees to the extent necessary for the efficient performance of the Institute.

13. *Baajataa*

13. *Budget*

The sources of the budget of the Institute shall be the following:

1. Budgetary allocations provided by the Regional State;
2. Funds or other properties obtained from assistance and other sources.

14. *Books of Accounts and Records*

1. The Institute shall keep complete books of accounts and financial records.
2. The books of accounts and financial records of the Institute shall be audited annually by the Auditor General of the Regional State or by an auditor delegated by him.

15. *Inapplicable Laws*

Any law, directive or practice which is inconsistent with this Proclamation shall not apply with respect to matters provided for in this Proclamation.

16. *Effective Date*

This Proclamation shall enter into force as of the 13th day of March 2000.
