A Proclamation to Provide for the Establishment of the Capital city of the Oromia Region

1. **Short Title**
This Proclamation may be cited as the "Establishment of the Capital City of the Regional State of Oromia Proclamation No.35/2000."
2. **Definitions**
Unless the context requires otherwise, in this Proclamation:
 - 1) "Executive Committee of the Council" means the executive Committee of the Council of the Regional State of Oromia.
 - 2) "Urban/Town Administration Proclamation" means the Proclamation issued to establish the administration of towns in the Oromia Region No.26/1999.
3. **Establishment**
 - 1) Adama is established as a Capital City of the Oromia Region from the 12th of July,2000.

Bulchiinsi Adaamaa Aangoo fi hojii Labsii Bulchiinsa Magaalaa keessatti Zoonii Addaatiif keenname ni qabaata. 2. Koreen Hojii Raawwachiiftuu Caffee haala Lahbsii Bulchiinsa Magaalaa keewwata 16 (1) jalatti ibsameen koree Hojii Raawwachiiftuu Magaalicha bulchu moggaasuu ni dnd’a. 5. <i>Angoo Dambii Baasuu</i> Labsii kana hojiirra oolchuuf Koreen Hojii Raawwachiiftuu Caffee Dambii fi qajeelfma baasuu ni danda’a. 6. <i>Seerota Raawwatiinsa Hinqabne</i> Labsi kanaan kan wal-faallessu seerri ykn qajeelfamni ykn haalli hojii kam iyyuu dhimmoota Labsii kana keessatti ibsaman irratti raawwatiinsa hinqabatu. 7. <i>Yeroo Labsiichi Itti Ragga’u</i> Labsiin kun Adoolessa 5, bara 1992 irraa jalqabee kan ragga’u ni ta’a. Finfinnee, Adoolessa 5, bara 1992 Kumaa Danmaqsaa Pirezidaantii Mootummaa Naannoo Oromiyaa	፩. የክልሉ መንግሥት መደበኛ ሥራውን ሙሉ በሙሉ በአዳማ ከተማ አስከሬኒ ጽ/ቤት በፈንፊኔ ከተማ ውስጥ መገልገል ይቀጥላል። ፪. በዚህ አንቀጽ በንዑስ አንቀጽ (፩) ሥር የተጻፈው ቢኖርም፡ የአድዋ ሕዝብ በኢትዮጵያ ፌዴራላዊ ዴሞክራሲያዊ ሪፐብሊክ ሕገ መንግሥት መሠረት በፈንፊኔ ላይ የተረጋገጠለት መብቱ እንደፀና ይቆያል። ፫. ከዚህ ቀደም በመገለጥ አድሚኖ ውስጥ የክልሉ መንግሥት አስፈጻሚ አካል ዋና መ/ቤት “ፈንፊኔ” ተብሎ ተደንግጎ የነበረው ቀርቶ “አዳማ” ተብሎ ተተክሏል። ፬. <u>የርዕስ ከተማው አስተዳደር ሥልጣንና ተግባር</u> ፩. የአዳማ ከተማ አስተዳደር በከተማ አስተዳደር አዋጅ ውስጥ ለልዩ ዞን የተሰጠው ሥልጣንና ተግባር ይናረዋል። ፪. የም/ቤቱ ሥራ አስፈጻሚ ኮሚቴ በከተማ አስተዳደር አዋጅ አንቀጽ ፲፮ (፩) መሠረት ርዕስ ከተማውን የሚያስተዳድር ሥራ አስፈጻሚ ኮሚቴ ለመሰየም ይችላል። ፫. <u>ደንብ የማውጣት ሥልጣን</u> የም/ቤቱ ሥራ አስፈጻሚ ኮሚቴ ይህንን አዋጅ ሥራ ላይ ለማዋል ደንብ እና መመሪያ ለማውጣት ይችላል። ፬. <u>ተፈጻሚነት ስለማይኖራቸው ሕጎች</u> ከዚህ አዋጅ ጋር የሚቃረን ማንኛውንም ሕግ ወይም መመሪያ ወይም የአሠራር ሁኔታ በዚህ አዋጅ ውስጥ በተጠቀሱት ጉዳዮች ላይ ተፈጻሚነት አይኖረውም። ፭. <u>አዋጁ የሚጸናበት ጊዜ</u> ፪. በዚህ አንቀጽ በንዑስ አንቀጽ (፩) ሥር ይህ አዋጅ ከሐምሌ ፮ ቀን ፲፱፻፺፪ ዓ.ም. ጀምሮ የጸና ይሆናል። ከ-ማ ደምቅዛ የአድሚኖ ክልላዊ መንግሥት ፕሬዚዳንት	2) Until the Regional State commences its regular functions fully in Adama, Finfine shall continue to serve as the Capital City of the Regional State. 3) Notwithstanding the provisions of sub-article (1) of this Article, the special interest of the Oromo people recognized under the Constitution of the Federal democratic Republic of Ethiopia shall remain valid. 4) The provisions specifying “Finfine” in the Megeleta Oromia, as the Head office of the Executive organ of the Regional State shall be repealed and replaced by “Adama” 4. <i>Powers and Duties of the Administration of the capital City</i> 1) The Administration of Adama (Capital City) shall have the powers and duties given to a Special Zone under the Urban/Town Administration Proclamation. 2) In accordance with Article 16 (1) of the Urban/Town Administration Proclamation, the Executive Committee of the Council shall have a power to designate an Executive Committee which administers the Capital City. 5. <i>Power to Issue Regulations</i> The Executive committee of the Council shall have a power to issue Regulations and Directives for the implementation of this Proclamation. 6. <i>Inapplicable Laws</i> Any law or directive or practive incosistent with this Proclmation shall not be applicable with respect to matters provided for in this Proclamation. 7. <i>Effective Date</i> This Proclamation shall come into force as of the 12th day of July, 2000.
