A PROCLAMATION TO AMEND THE PROCLAMATION ESTABLISHING OROMIA OFFICE OF POPULATION

- Short Title**
This Proclamation may be cited as
the “Oromia Office of Population
Establishment Proclamation No.
1997 (Amendment) Proclamation
No. 39/2000.”
- Amendment**
Powers and duties given to Oromia
Office of Population by Proclamation
No. 14/1997 as well as the
rights and obligations of the Office
are hereby transferred to Oromia
Planning and Economic Development
Bureau.
- In applicable Laws**
Any law or practice which is inconsistent
with the provisions of this
Proclamation shall not apply with
respect to matters provided for
in this Proclamation.
