PROCLAMATION NO. 44/2001
A PROCLAMATION TO PROVIDE
FOR THE ESTABLISHMENT OF
THE OROMIYA AGRICULTURAL
RESEARCH INSTITUTE

WHEREAS; it is believed that research for generating technologies; improving indigenous technologies and adapting foreign technologies in line with the regional agricultural development strategy is a decisive activity to develop agriculture which forms the base for the development of Oromiya's economy & the social welfare of its people;

WHEREAS; it has been found essential that research shall be undertaken in a systematic and coordinated manner in order to ensure sustainable development in production and productivity of the agricultural sector of the region;

WHEREAS; it has become necessary to establish an organization which shall be responsible for coordinating; encouraging and assisting research activities in the region on sustainable basis;

NOW, THEREFORE; in accordance with article 49 (3)(a) of the constitution of the Regional State of Oromiya; it is hereby proclaimed as follows:

1. *Mataduree Gabaabaa*
Labsiin kun Labsii Inistiitutii Qorannoo Qonnaa Mootummaa Naannoo Oromiyaa Hundessuuf bahe lakk. 44/1993 jedhamee waamamuu nida-da'a.

2. *Hiika*
Akaataan seensa jechichaa hikkaa biraa kan kennisiisu yoo ta'e malee, Labsii kana keessatti:

1. "Giddu-galeessa qorannoo qonnaa" jechuun giddu-galeessoota qorannoo qonnaa Naannoo Oromiyaa ta'anii harka guutu qorannoo qonnaa irratti kan bobba'an hundaa jechuudha.
2. "Koree" jechuun koree hojii raawwachiiftuu Mootummaa Naannoo Oromiyaati;
3. "Nama" jechuun 'nama uumamaa ykn seeraan mirgi namummaa kan kennameef jechuudha
4. "Qabeenya uumamaa" jechuun bosona, biyye, bishaani fi kan kana wajjiin kan walqabate haala qilleensaas kan hammatu ta'a;

1. *Short Title*

This proclamation may be cited as the "Oromiya Agricultural Research Institute Establishment Proclamation No. 44/2001.

2. *Definition*

Unless the context otherwise requires; in this Proclamation:

1. "Agricultural Research Center" means an agricultural research organ of Oromiya that is conducting agricultural research on full time bases.
2. "Executive committee" means the executive committee of the Oromiya Regional State.
3. "Person" means a Natural or Juridical person.
4. "Natural resource" means soils; forest, water and climate that are related to agriculture.
5. "Agricultural Research" means research under taking aimed at improving the production & productivity of plants; animals, and natural resources, including socio economics, research extension and related fields.

3. *Establishment*

1. The Oromiya Agricultural Research Institute (hereinafter referred to as the "Institute") is hereby established by this proclamation.
2. The head office of the Institute shall be in the capital of the region.

4. *Objectives*

The Institute shall have the following objectives:

1. Generate; develop and adapt agricultural technologies that are in accordance with the regional agricultural development policy and strategy and improve the living standard of the population in the region.
2. "Coordinate research activities of agricultural research centers; higher learning institutes and other related establishments which undertake agricultural research.
3. 'Build up a research capacity and establish a system that will make agricultural research efficient; effective and concurrent with the development needs of the region.

1. Boordii Instiitutii Qorannoo Qonnaa (kanaan booda Boordii jedhamee kan waamamu),

2. Boordiidhaan dhiyaatee koreedhan kan mudaman Daaraktera Ol'aana fi Itti Aantota Daaraktaroota ol'ano,

3. Gidu galeessoota qorannoo qonnaa, fi

4. Hojjattoota barbaachisaa ta'an.

6. *Miseensoota Boordii*

Dura taa'aa Boordichaa dabalatee miseensoti Boordii baay'inni isaanii shanii gad kan hin taane, koreen ni filatamu.

3. “Build up a research capacity and establish a system that will make agricultural research efficient; effective and concurrent with the development needs of the region.

4. “Popularize agricultural research results.

5. *Organization*

The Institute shall have:

1. Oromiya Agricultural Research Board (hereinafter referred to as “Board”)

2. A Director General and Deputy Director Generals to be appointed by the council upon presentation by the board

3. Agricultural research centers and

4. Necessary staff

6. *Members of the Board*

The board, whose members including the chairperson, shall not be less than five will be appointed by the council.

7. *Powers and Duties of the Board*

The board shall be accountable to the Council and shall have the following powers and duties;

1. Overview and direct the powers and duties of the institute enumerated in article 9 of this proclamation and supervise and follow up their implementation.

2. Present the Organizational structure of the institute and centers to the council for approval and follow up the implementation thereafter.

3. Submit to the council the directives in which the personal of the Institute will be administered for approval and implementation thereof.

4. Review the annual work program and budget of the Institute and submit to the government for approval.

5. Decide the working relationship between the Institute and the federal and other related regional research establishments in consultation with appropriate bodies.

6. Establish a technical advisory committee, designate members of the committee and receive technical evaluation report from the committee before approving project proposals, programs and budget.

7. Follow up the activities of the research-extension-farmer linkages.

8. Determine its own internal rules and regulations.

8. Meeting of the Board

1. The board shall meet ones in two months any may have extraordinary meetings as necessary.

2. There shall be a quorum where a simple majority of the members of the board are present.

3. Decision of the board shall be made by a majority vote. In case of a tie the chair person shall have a casting vote.

9. Powers and Duties of the Institute

The Institute shall have the following powers and duties.

1. Formulate agricultural research strategy and policy; and determine on research priorities; develop work plans and programs and implement when approved by the government and follow up the implementation thereof.

2. Issue guidelines for the proper formulation and preparation of agricultural research programs and projects in line with the region's development requirements.

3. Undertake or cause the undertaking of agricultural research activities on the base of the regional agricultural research policy and strategy.

4. Advertise agricultural research results and issue guidelines for their implementation by the users in collaboration with the relevant organs.

5. Based on the region's agricultural research policy and strategy; submit studies to the board for decision to re-organize or dissolve existing research centers and establish new ones as deemed necessary; implement the decision thereof.

6. In collaboration with different organs; expand agricultural knowledge of the society; popularize research results.

7. Collect; organize documents and disseminate information on agricultural research activities that are available in the country and elsewhere in the world; develop and guide information exchange system.

8. Qaama dhimmi ilaalu waliin tahudhaan Naannicha keessatti qorannoo qonnaa, mala qonnaa fi barnoota qonnaa gidduu waldeegarsi hojii akka jiraatu haala mijeessuu;

14. Establish system for research project review and information exchange to avoid unnecessary duplication of efforts on research projects being conducted at the regional and federal research centers.

15. Give permit to, register and maintain the list of, any person involved or will be involved in agricultural research

16. Own properties; enter in to agreements; sues and be sued.

17. Submit reports on works accomplished to the concerned body.

18. Accomplish other related tasks in order to fulfill its objectives.

1. Guide and supervises the institute's over all activities.
2. Prepare work program and budget of the institute and submit to the board for approval by the government; control and follow up the implementation thereof.
3. Employ, administer and fire employees in accordance with the approved directives.
4. Represent the institute in its relations with their parties.
5. Follow up activities of the Institute being a member and secretary of the board.
6. Opens and activates the institution's bank accounts.
7. In order to facilitate the institution's work, the director general may delegate part of his powers and duties to the other officials and staff of the institute.
8. Perform other duties given by the board.

11. Powers and Duties of the Regional Agricultural Research Centers

The agricultural research centers shall be accountable to the institute and shall have the following duties;

1. Undertake agricultural research activities and programs designed to be executed by the center; in accordance with the agricultural research policies and strategies; accomplish administrative and technical duties.
2. Prepare detailed research projects and budgets based on the programs approved to be executed by the center and implement when approved thereof.
3. Based on the region's agricultural research policy and strategy, prepare the centers future direction and development plan; prepare and submit the material and man power requirements of the center to the institute for approval and follow up the implementation.
4. Submit reports on accomplished duties.
5. Perform other duties based on the directives given by the institute.

12. *Transfer of Rights and Obligations*

1. The rights, obligations and duties of Agricultural Research Centers, Ziway Fishery Research Center and Rural Technology Promotion Centers are hereby transferred to the institute established under this Proclamation.

13. *Source of Income*

The Institute shall have incomes from the following sources;

1. Budget allocated by the regional government.
2. Sales of research by-products and different services.
3. Assistance and grants.

14. *Book of Accounts*

1. The Institute shall keep a complete book of accounts
2. The institute's book of accounts shall be audited at least once a year by auditor general of the region or by another auditor designated by him.

15. *Inapplicable Laws*

Any other laws, directives or conditions of duties that are in contradiction with this Proclamation shall not be applicable with respect to matters provided for in this Proclamation.

16. *Effective Date*

This Proclamation shall enter into force as of July 07, 2001
