**A PROCLAMATION TO PROVIDE
 FOR THE LEGISLATIVE
 PROCEDURE OF THE ‘CAFFEE’**

WHEREAS, the Oromia Regional
 State Constitution Provides that the
 ‘Caffee’ Oromia has the legislative
 power;

WHEREAS, this power to legislate
 shall be exercised properly where the
 ‘Caffee’ consulted upon by having the
 legislative procedure to follow;

Whereas, the legislative procedure
 ought to emphasize the democratic
 tenets, make the modus operandi of
 ‘Caffee’ transparent to the public and
 make the public participatory;

NOW, THEREFORE, in accordance
 with Article 49 (3) (a) of the cons-
 titution, it is hereby proclaimed as
 follows:

1. Short Title

This proclamation may be cited as
 the ‘Caffee’ Legislative procedure
 proclamation No. 48/2001.

2. Hiikaa

Labsii kana keessatti:

- 1) “Caffee” jechuun qaama seera baastuu mootummaa naannoo Oromiyaati.
- 2) “Seera” jechuun seera haala labsii kana keessatti tumameen Caffee dhaan ragga’ee mallattoo Preezidaantii bulchiinsa mootummaa naannichaatiin magalata Oromiyaa irratti maxxanfamee seera hojii irra oolu jechuudha.
- 3) “Af-yaa’ii” yookiin “Itti-aanaa Af-yaa’ii” jechuun akkuma tartiiba isatti, Af-yaa’ii yookiin itti-aanaa Af-yaa’ii Caffee ti.

3. Waa’ee Wixinee Seeraa Dhiyeessuu

1. Miseensi Caffee kamiyyuu dhimma kamiyyuu irratti Caffeen akka seera baasu wixinee seeraa dhiyeessuu ni danda’a. Wixineen seeraa kun mariif dhiyaachuuf mallattoo mi seensota Caffee 20n deegarammu qaba.
2. Manni Maree Bulchiinsa Mootummaa Naannichaa wixinee seeraa Caffee dhiyeessuuf mirga qaba.
3. Wixineen seeraa kamiyyuu barreeffamaan Af-yaa’ii Caffee tiif dhiyachuu qaba.
4. Af-yaa’iichi akkuma wixineen seeraa isaaf dhiyaateen koree dhimmi ilaalu akka gahuufii dubbifama durattif ajandaan akka qabamuuf ni tasisa.

4. Dubbifama Duraa

- 1) Wixineen seeraa ajandaan qabameef Af-yaa’ichaan yookiin miseensa wixinee seeraa kana dhiyeeseen walgahii koreewwan sadaniif dubbifamuudhaaf ni dhiyaata; irrattis ni mari’atama.
- 2) Ega dubbifamee irratti mari’atamee booda, miseensota koreewwanii harka afur keessaa sadii yoo deeggaran wixineen seeraa dhiyaate koree dhimmi ilaaluuf ergama.

፪. ትርጓሜ

በዚህ አዋጅ ውስጥ፡-

፩. “ጨፌ” ማለት የኦሮሚያ ክልላዊ መንግሥት ሕግ አውጪ አካል ነው።

፪. “ሕግ” ማለት በዚህ አዋጅ በተደነገገው መሠረት በጨፌ ፀድቆ በክልሉ መስተዳድር ፕሬዚዳንት ፊርማ በመገለጥ የኦሮሚያ ታትሞ በሥራ ላይ የሚውል ሕግ ማለት ነው።

፫. “አፈጉባኤ” ወይም “ምክትል አፈጉባኤ” ማለት እንደቅደም ተከተሉ የጨፌ ኦሮሚያ አፈጉባኤ ወይም ምክትል አፈጉባኤ ማለት ነው።

፫. የሕግ ረቂቅ ስለማቅረብ

፩. ማንኛውም የጨፌ አባል በማናቸውም ጉዳይ ላይ ጨፌ ሕግ እንዲያወጣለት የሕግ ረቂቅ ለማቅረብ ይችላል። ሆኖም የሕግ ረቂቁ ለውይይት ለመቅረብ፣ የ20 የጨፌ አባላት ፊርማ ድጋፍ ማግኘት አለበት።

፪. የክልሉ መስተዳድር ምክር ቤት የሕግ ረቂቅ ለጨፌ የማቅረብ መብት አለው።

፫. ማንኛውም የሕግ ረቂቅ በጽሑፍ ለጨፌ አፈጉባኤ ይቀርባል።

፬. አፈጉባኤው የሕግ ረቂቅ እንደ ቀረበለት ለሚመለከተው ኮሚቴ እንዲደርስና ለመጀመሪያ ንባብ አጀንዳ እንዲያዝለት ያደርጋል።

፬. የመጀመሪያ ንባብ

፩. አጀንዳ የተያዘለት የሕግ ረቂቅ በአፈጉባኤው ወይም የሕግ ረቂቁን ባቀረበው አባል አማካይነት ሦስቱም ኮሚቴዎች በተገኙበት ስብሰባ በንባብ ይቀርባል። ውይይትም ይደረግበታል።

፪. ከንባብና ውይይት በኋላ ሦስት አራተኛ የሚሆኑ የኮሚቴዎች አባላት ከደገፉት ረቂቅ ሕግ ለሚመለከተው ኮሚቴ ይመራል።

2. Definition

In this Proclamation:

1) ‘Caffee’ means the legislative organ of Oromia Regional State.

2) ‘Law’ means laws that come into force upon approval by the ‘Caffee’ Oromia and subsequent publication in Magalata Oromiyaa under the signature of the President.

2) ‘Speaker’ or ‘Deputy Speaker’ means the Speaker or Deputy speaker of the ‘Caffee’ Oromia respectively.

3. Submission of Draft Legislation

1. Every member of the ‘Caffee’ may submit a draft legislation on any matter, for promulgation by the ‘Caffee’. However, it shall be endorsed by the signature of at least, 20 members of the house in order to present it for discussion.

2. The Administrative Council of the Region has the right to submit draft legislation to the ‘Caffee’.

3. All draft legislation shall be submitted, in written form, to the Speaker of the ‘Caffee’.

4. The Speaker shall, upon submission of a draft legislation to him, refer to the concerned committee to be itemized in the agenda for preliminary reading.

4. Preliminary Reading

1. A draft legislation itemized in agenda shall be read out by the Speaker or by a person who submitted the draft legislation and discuss upon, at the meeting the three committees are present.

2. Upon completion of the reading and discussion, the draft legislation shall be directed to the concerned Committee if the three fourth of the committee members vote in favor.

5. *Koreewwan Dhaabbatoo*

1. Caffeen koreewwan dhaabbatoo kanatti aanan niqabaata:
 - a) Koree Seeraa
 - b) Koree Dinagdee, Baajataafi Fayinaansii fi
 - c) Koree Gamtaa'ina Ummataatiifi Dhimma Hawaasummaa.
2. Caffeen akka barbaachisummaasaatti, koreewwan yeroo gurmaessuu ni danda'a.
- 3) Tokko tokkoon koree miseensota hanga sagalii niqabaata.
- 4) Miseensi Caffee tokko yeroo tokko keessatti miseensa koree tokko ol tahuu hindanda'u.
- 5) Walitti qabaafiibarreesaan koreewwanii Caffeedhaan filatamu.
- 6) Tokko tokkoon koreewwanii qooda hojiisaaf akkaataa itti hojatu ilaalchisee qajeelfama tarreeffamaa qopheessee Caffeedhaan raggaasisa.

6. *Akkaataa Hojii Koreewwanii*

Akkaataa Labsii kana keewwata 4(2) jalatti ibsameen wixineen seeraa tokko mallattoo Af-yaa'ichaatiin koree dhimmi ilaaluuf akkuma ergameen, korichi akka barbaachisummaasaatti:

- 1) miseensotni Caffichaatiif, manneetii mareewwan aanaafi gandaa yaada akka irratti kennan haala ni mijeessa;
- 2) Sadarkaa naannootti waltajjii kanneen dhimmichi isaan ilaalu yaada irratti akka kennan ni taasisaa;
- 3) Gabaasaa yaadaafi yaada murtii dhimmicha irratti qopheessee fi wixinee seeraa isa dhumaa Af-yaa'ichaf ni dhiheessa.

7. *Akkaataa Seerri Itti Ragga'u*

- 1) Af-yaa'ichi wixineen seeraa inni dhumaa miseensota Caffee akka gahu ni taasisa.
- 2) Wixineen seeraa miseensota Caffee gahee yeroon qo'annoo gahan erga kennameefii booda, yaa'ii idilee Caffetiin yookiin akkuma barbaachisummaasaatti, walgahiiwwan adda addaa itti fufiinsaan adeemsisifamanii fi walgahiiwariiifachiisaa irratti ilaalamu Af-yaa'ichi laa ni qaba.

5. *Standing Committees*

1. The 'Caffee' shall have following standing Committees:

(a) the legal Affairs Committee;

(b) the Economic, Budgetary and Finance Committee and

(c) People's Organization and social affairs Committee.

2. The 'Caffee' may form additional Committees as necessary.

3. Each Committee may have upto nine committee members.

4. No Deputy shall be member more than one committee.

5. The Chairman and Secretary of each committee shall be directly elected by the 'Caffee'.

6. Each committee shall draw its own rules of procedure and have it approved by the 'Caffee'.

6. *Mode of Operation of Committee*

Upon a draft legislation being referred to the concerned committee in accordance with Article

4(2), under the speaker's signature the Committee, as may be necessary, shall:

1) make an arrangement where by the 'Caffee' members, the District and Kebele Councils give their opinions thereon;

2) arrange a forum at the regional level where by all concerned with the matter voice their opinion thereon;

3) Submit to the speaker a report consisting of summarized opinion, decision proposal and the least draft legislation.

7. *Conditions for the Approval*

1) The speaker shall cause the draft legislation to be sent out to all the Deputies.

2) Subsequent to the lapse of sufficient time allocated for examination of the draft since reception by the Deputies, the speaker shall itemize in the agenda for consideration in regular meeting or as may be necessary in consecutive and extraordinary meetings of the 'Caffee'.

- 3) Caffeen erga mari'atee booda, wixinee seeraa dhiyaate irratti waliigalusa, fooyyeessuusaa, ragg-aasuusaa yookiin kuffisuusaa sagalee caalmaatiin ni murteessa.
- 4) Af-yaa'ichi ejjannoo Caffeen wixinee seeraa dhiyaate irratti fudhate ifa nigo-dha.

8. **Waa'ee Maxxanfamuu**
Pireezidaantiin bulchiinsa mootummaa naannoo Oromiyaa haala labsii kanaatiin seera ragga'e lakkoofsa kennuudhaan mallattessee Magaalota Oromiyaa irratti akka maxxanfamee bahu ni godha.
9. **Yeroo Labsiin kun Itti Ragg-a'uu**
Labsiin kun Onkoloolessa 18 bara 1994 irraa eegalee kan hojjiirra oolu taha.

3) Subsequent to having sufficiently deliberated on the report, the 'Caffee' shall decide, by a majority vote, on whether to accept, modify, approve or reject the draft legislation.

4) The Speaker shall make official declaration of the position taken by the 'Caffee' on the draft legislation.

8. **Publication**
The Oromia Regional Administrative Government President shall cause, the law approved pursuant to this proclamation, to be published in 'Magalata Oromiyaa' after numbering and signing it.

9. **Effective Date**
This proclamation shall enter into force as the 28th day of October, 2001.
