PROCLAMATION NO. 5/1996

A PROCLAMATION TO DEFINE
THE RIGHTS AND DUTIES OF
COUNCIL MEMBERS

WHEREAS Council members
shoulder heavy responsibilities of pub-
lic service entrusted to them by their
electorate;

WHEREAS it is necessary to de-
fine the rights and duties of Council
members to enable them to properly
discharge their responsibilities;

WHEREAS it is also deemed
essential to specify the modalities by
which the electorate may recall council
members when they no longer comm-
and their confidence or removed when
they are unable to carry out their
functions;

NOW, THEREFORE, in accor-
dance with Article 49 (3) (a) of
the Constitution of the Oromia Region-
al State, it is hereby proclaimed as
follows.

1. Mata Duree Gabaabaa

Labsiin kun "Labsii murteessaa Mirgaa fi Dirqama miseensota Caffee Lakk. 5/1988" jedhamee waamamuu ni danda'a.

2. Hiikkaa

Akkaataan jechichaa hiikkaa biraa kan kennisiisuuf yoo ta'e malee, Labsii kana keessatti:-

a) "Caffee" jechuun akka Heera Mootummaa Naannoo Oromiyaa keewwata 46 (1) ykn 74 (1) tti kan hundeeffame Caffee Oromiyaa yookiin Caffee Aanaati.

b) "Koree hojii Raawwachiiftuu" jechuun akka Heera Mootummaa Naannoo Oromiyaa keewwata 53 (1) ykn 69 (7) ykn 77 (8) tti kan hundeeffaman koree Hojii Raawwachiiftuu Mootummaa Naannoo Oromiyaa yookiin Bulchiinsa Godinaa ykn Caffee Aannootaati.

c) "Miseensa" jechuun bakka bu'aa ummataa akka Heera Mootummaa Naannoo Oromiyaa Keewwata 48 (1) ykn 76 tti kan filatame miseensa Caffee Oromiyaa yookiin Caffee Aanaati.

3. Bara Hojii

Heala biraatiin yoo murtaawe malee, barri hojii miseensa Caffichaa bara Hojii Caffichaa ti ta'a.

4. Waa'ee Waraqaa Eenyummaa

1. Miseensa kamiifiyyuu waraqaan eenyummaa dhaabbataan ni keennamaaf.

2. Waraqaan eenyummaa kennamuufis kan tejaajilu hanga barri hojii isaa dhummulti-ykn hanga miseensummaa irraa dhaabbatutti ta'a.

5. Waa'ee Itti Waamamaa

1. Miscensi Kamiyyuu itti waamani isaa ummata kallattiin isa filatee fi Caffee miscensummaan itti filatameef taha.

፬. ስለመታወቂያ ወረቀት

፩. ለማንኛውም የምክር ቤት አባል ቋሚ የሚሆን የመታወቂያ ወረቀት ይሰጠዋል።

፪. የመታወቂያ ወረቀቱ የሚያገለግለው እስከ ሥራ ዘመኑ መጨረሻ ወይም ከአባልነት እስከሚነሳ ድረስ ይሆናል።

፭. ስለተጠሪነት

፩. ማንኛውም የምክር ቤት አባል ተጠሪነቱ በቀጥታ ለመፈጠሩ ሕዝብና አባል ለሆነበት ምክር ቤት ይሆናል።

1. Short Title

This Proclamation may be cited as the "Definition of Rights and Duties of Council Members Proclamation No. 5/1995".

2. Definitions

In this Proclamation, unless the context requires otherwise:

a) "Council" means the Council of the Oromia Regional State or a district council in the Region established in accordance with Article 46 (1) or 74 (1), respectively, of the Constitution of the Oromia Regional State;

b) "Executive Committee" means the Executive Committee of the Oromia Regional State, a zonal administration or an executive committee of a district council established in accordance with Article 53 (1) or 77 (8), respectively, of the Constitution of the Oromia Regional State.

c) "Council member" means a member of the Council of the Oromia Regional State or a district council in the Region elected in accordance with Article 48 (1) or 76, respectively, of the Constitution of the Oromia Regional State.

3. Term of Office

Unless expressly provided otherwise, the term of office of a council member shall be the tenure of the council of which he is a member.

4. Identification Card

1. Every council member shall receive a proper identification card.

2. The identification card shall be valid until the term of office of a council member expires or he is recalled or removed from his council membership.

5. Accountability

1. Every council member shall be accountable to his electorate and to the council of which he is a member.

 - b) Fedhii ummaticha isa bakka buufatee guutuu; bu'uura go-dhachuudhaan hojjechuu.
7. Hojjaa kan Biroo Irratti Bobba'uu
Miseensi kamiyyuu:-
- a) Hojii miseensummaa isaa wajjin kan wal hin faallesine yookiin,
 - b) Qooda hojii Caffee keessaa qabu kan hin hir'ifne hojii kan biro irratti bobba'uu ni danda'a.
8. Mirga Addaa Miseensummaa
1. Miseensi Caffee kamiyyuu osoo yakka ulfaataa raawwatu harkaa-harkatti yoo qabame malee, Caffeen inni miseensa itti tahe osoo hin heeyya-miin hin qabamu; yaakkaan hin himatamu.
 2. Miseensi kamiyyuu Walga'ii Caffee miseensa itti ta'ee irratti yookiin hojii miseensummaa isaa yeroo raawwatu yaa-da dhiyeessuuf naamusaaniis Seraanniis hin gaafatamu; hin himatamu.
 3. Miseensi kamiyyuu yakka ulfaataa raawwatee harkaa harkatti yoo qabame qaamni qabe sun haala isaa sa'atii 48 keessatti Caffee inni miseensa itti ta'etti; yeroo Caffichi wal hin geenye Koree Hojii Raawwachiiftuu dhimmi ilaaluutti beeksisuu qaba.

- ፩. ማንኛውም የምክር ቤት አባል ከባድ ወንጀል ሲፈጽም እጅ ከፍንጅ ካልተያዘ በስተቀር፤ አባል የሆነበት ምክር ቤት ሳይፈቅድ አይያዝም በወንጀለኛ አይከሰስም ።
- ፪. ማንኛውም አባል በምክር ቤት ስብሰባ ላይ ወይም የአባልነት ሥራውን በሚያከናውንበት ወቅት በሚያቀርበው ሃሳብ ምክንያት በዲሲፕሊን አይከሰስም ፤ አብረታ አይቀርብበትም ።
- ፫. ማንኛውም የምክር ቤት አባል ከባድ ወንጀል ሲፈጽም እጅ ከፍንጅ ከተያዘ አባሉን የያዘው ከፍል ከያዘበት ጊዜ አንስቶ በአርባ ሰዎች ሰዓት ውስጥ አባል የሆነበት ምክር ቤት ምክር ቤቱ ባልተሰበሰበበት ጊዜ ለሚመለከተው ሥራ አስፈጻሚ ኮሚቴ ማስታወቅ ይኖርበታል ።

2. Without prejudice to the provisions of sub-Article (1) of this Article, a member of a district council shall also be accountable to the executive committee of his respective zonal administration and to the Council of the Oromia Regional State.
6. *General Principles on the Activities of Council Members*
Every council member shall:
- a) enforce the Constitution, laws and decisions of the Regional State;
 - b) exert every effort to promote the interests and fulfill the needs of his electorate.
7. *Engagement in Other Activities*
A council member may engage in any other activity, trade or occupation so long as:
- a) it is not compatible with his official duty, and
 - b) it does not hinder his participation in the council of which he is a member.
8. *Immunities of Council Members*
1. No council member shall be arrested or prosecuted without the permission of the Council of which he is a member unless he is apprehended in flagrante de licito for a serious offence.
 2. No Council member shall be questioned for disciplinary actions, prosecuted or charged on account of opinions he expresses in council meetings or while discharging his official duty.
 3. Where a council member is apprehended in flagrante de licito for committing a serious offence, the arresting authority or organ shall, in forty eight hours, report the event to the council of which the arrestee is a member or, where the council is not in session, to its executive committee.

4. Miseensi kamiyyuu, akka keewwata kana keewwata xiqqaa (3) irratti ibsameen alatti, yakka raawwateera jedhamee akka qabamu yookaan hinia, tamu yeroo barbaadamu qaamni dhimmni isaa ilaalu haala isaa Caffee inni miseensa itti ta'etti, yeroo Caffichi wal hin geenye immoo koree Hojii Raawwachiiftuu dhimmni ilaaluuti beeksisa; Caffeen dhimmichi ilaalus walga'ii Caffee itti aanutti murtee itti kenna.

5. Miseensi kamiyyuu hojii miseensummaa isaa wajjin kan wal hin qabanne sababa dhimma Hariiroo Hawaasaatiin himatamuu isaa mirgi addaa keewwata kana keessatti tumame hin dhoorku.

9. *Miseensoota, Irratti Haala Tarkaanfiin Naamusaa Itti Fudhatamuu Danda'u*

1. Miseensi kamiyyuu naamusa isaa irraa eegamu yoo hir'isee argame yookiin gochi isaa hojii miseensummaa isaa wajjin kan wal hin simne yoo ta'e, akkaata dambii ittiin bulmata Caffee Miseensa itti ta'een tarkaanfiin naamusaa itti fudhatamuu ni danda'a.

2. Miseensi hir'ina naamusaatiin gaafatamu kamiyyuu mirga of irraa ittisuu ni qabaata.

10. *Gahee Hojii Miseensota Caffichan*

1. Miseensi kamiyyuu mirgaa fi dirqama kanatti aanan ni qabaata:-

a) Bakkeewwan hojii itti gaafatamummaa Caffichaa fi koreewwan adda addaa keessatti miseensummaan filachuufi filatamuu.

b) Dhimmoota Caffichi irratti mari'atu irratti daandii wal qixaa fi bilisa ta'een mari'achuu fi murteessuu,

c) Caffichi akka irratti mari'atu yaada marii dhiyeessuu,

ሀ/ በምክር ቤትና በልዩ ልዩ ኮሚቴዎች ሥራዎች ውስጥ በአባልነት የመምረጥና የመመረጥ፤

ለ/ ምክር ቤቱ በሚወያይባቸው ጉዳዮች ላይ ነጻና እኩልነት ባለው መንገድ አስተያየት የማቅረብና ውሳኔ የመስጠት፤

ሐ/ ምክር ቤቱ እንዲመክርባቸው የመወያየት ሀሳቦችን የማቅረብ፤

4. Where the council member is to be arrested or prosecuted under circumstances other than the one specified in sub-Article (3) of this Article, the concerned government organ shall submit the case to the appropriate council or, when it is not in session, to its executive committee. The Council shall deliberate upon the matter in its next session.

5. The immunity provided for in this Article is no bar to the initiation of civil actions against a council member in his personal capacity.

9. *Manner of Taking Disciplinary Measures*

1. Any Council member who breaches disciplinary rules or whose conduct is found to have been incompatible with his official duty is subject to disciplinary measures in line with the internal regulation of the council of which he is a member.

2. A council member against whom disciplinary actions have been initiated shall have the opportunity to present his case.

10. *Functions of Council Members*

1. Every council member shall have the following rights and functions:

a) to take part, elect and be elected in the various committees of the council of which he is a member;

b) to express opinions and decide on matters that are being considered by the council on the basis of freedom and equal opportunity;

c) to forward issues to be deliberated upon by the council;

d) Yaadaa fi komii ummata isa filate irraa dhiyaatu fuudhee qaamota Mootummaa Naannoo dhimmi isa ilaalu wajjin irratti mari'atee akka furmaata argatan tattaa'ffii gochuu.

e) ummata isa filateef yeroo yerootti ykn yeroo uummatichi isa gaafatu:

I) Hojiiwwan caffichaan raawwataman,

II) Yaadaafi komii ummata isa filate ilaalchisee tarkaanfii fudhataman.

III) Hojii miseensummaa isaa raawwachuuf sochii godhe irratti gabaasa dhiyyeeyesuu.

2. Miseensi Caffee Oromiyaa mirgoota kanaa olitti ibsamani irratti dabalatee mirga seera burqisiisuu ni qabaata.

11. Haallan Miseensummaa Irraa

Nama Kaasisan

Miseensi kamiyyuu haallan armaan gaditti ibsamaniin miseensummaa irra kaa'uu ni danda'a.

a) Ummatni isa filate yoo amartaa isa irratti dhabe yookiin.

b) Sababa rakkina dhuunfaa humnaa ol ta'een haallan hojii miseensummaa itti fufuu isa hin dandessifne yoo uumaman yookiin.

c) Yakka himatameen manni murtii murtee balleessaa dhuumaa yoo irratti kenne yookiin ajajni manni murtii kenne kan hojii isaa itti hin fufsiifne yoo ta'e yookiin.

d) Gocha saalfachiisaa yookaan qaaneffachiisaa addaa yookaan haamilee hawaasichaatiin wal-faallessu yoo raawwatee dha.

d) to strive to provide solutions for compliants and grievances of his electorate in cooperation with the appropriate executive organs of the Region;

e) to report to his electorate on occasions or when requested:

I) on activities accomplished by the council;

II) on actions taken on complaints and grievances of his electorate;

III) an account of his own personal accomplishments in the discharge of his official duties.

2. Every member of the Council of the Oromia Regional State shall, in addition to the rights and duties prescribed in the foregoing sub-Article, have the right to initiate laws.

11. Conditions for Recall or Removal

A council member shall be recalled or removed from his official position where:

a) the electorate has lost confidence in him or;

b) he is not in a position to discharge his responsibilities for reasons beyond his control or;

c) he has been orinally convicted by a court of law or where a court decision prevents him from discharging his duty or;

d) he is found to have committed a social aberration which is generally believed to be humiliating and immoral.

12. Miseensummaa Irraa Kaasuuf Akkaataa Gaaffiin Itti Dhiyaatu

1. Ummatni miseensa filate irratti yoo amantaa dhabe miseensummaa irra akka ka'u gaaffiin ka'uumsaa dhaaba isa kaadhimeen yookiin ummata isa filateen dhiyaachuu ni danda'a.
2. Miseensi nakkina hummaa ol ta'een yoo hojii miseensumman itti fufuu dadhabe miseensummaa irra ka'uuf ofii isaa, kan ofii dhiyeessuuf hin dandeenye yoo ta'e maatii yookiin bakka bu'aa isaatiin gaaffii dhiyeeffachuu ni danda'a.
3. Miseensi yakkaan himatamee murteen balleessaa irratti kenname, ajaja manni murtii kenneen hojjaa isaa itti fufuu hin dandeenye yookiin gocha saalfachiisa yookaan qaneffachiisaa addaa yookaan hamilcee hawaasichaatiin wal faallesuu yoo raawwate, miseensummaa irraa akka ka'u gaaffiin miseensa Caffichaatiin yookaan Koree Hojii Raawwachiiftuu dhimmi ilaaluun dhiyaachuu ni dabda'a.
4. Miseensa kanatti yoo miseensummaa irraa ittisuuf gaaffiin dhiyaatu Caffee miseensa itti ta'etti, yeroo Caffichi wal hin geenye koree Hojii Raawwachiiftuu dhimmi ilaalutti ta'a.

13. Waa'ee Miseensota Miseensumma irraa haquu

1. Akkaataa Labsii kana keewwata 12 (1) itti gaaffii dhiyaatu Caffeen yookiin Koree Hojii Raawwachiiftuu gaaffiin itti dhiyaate koreedhaan qorachiisa.
2. Kan qorachiise Koree Hojii Raawwachiiftuu yoo ta'e miseensicha hojii irraa dhoorkee gabaasa wajjiin Caffee inni miseensa itti ta'eef walga'ii itti aanuutti dhiyeessa.
3. Caffeen dhimmichi ilaaluus gabaasa korichi dhiyeessuf qoratee gaaffiin dhiyaate yoo dhugaa ta'ee argame, miseensicha miseensummaa irraa akka haqu ummata isa filateef ni dhiyeessa.

12. Manner of Lodging Request for Recall or Removal of a Council Member

1. On account of loss of confidence, the request may be made by the political party that has nominated the member or by the electorate.
2. On account of circumstances beyond the control of the member, the request may be made by the member himself, by other members of his family or by his lawful agent.
3. Where removal is necessitated on account of criminal conviction or where it is due to the undesirable or immoral conduct of a member, the request is to be made by the concerned council or its executive committee.
4. The petition for removal is to be submitted to the council of which he is a member or, when it is not in sessions, to the concerned executive committee.

13. Manner of Recall of Council Members

1. A request made in accordance with Article 12(1) may be examined by a committee to be designated for this purpose by the concerned Council or its executive committee.
2. Where the investigation is initiated by the executive committee, it may suspend the member and report the case to the council.
3. Where the council endorses the finding after due consideration, it shall cause the matter to be referred to the electorate.

14. *Waa'ee Raawwannaa Murtee Miscensummaa Irraa ka'uu*

1. Akkaataa Iabsii kana keewwata 12 (2) fi (3) tti gaaffii, ka'uumsaa dhiyaateef Caffeen gaaffichi dhiyaateef yoo itti amane miseensicha miseensummaa Caffee irraa kaasuu ni danda'a.
2. Akkaataa keewwata kana keewwata xiqqaa (1) tti gaaffiin dhiyaate Koree Hojii Raawwachiistuu dhimichi ilaalutti yoo ta'e korichi dhimmicha Caffee, inni miseensa itti ta'etti dhiyeessee murteessisa.

15. *Adabbii*

Namni ykn dhaabni kamiyyuu miseensi tokko hojii isaa akka hin raawwatne seeraan alatti yoo jeeqe ykn dhoorke ykn gocha kabajaa a isaa tuqu kan isa irratti raawwate yoo ta'e seera malchiisuum ni adabama.

14. *Manner of Removal of a Member by a Council*

1. A council may remove a member if it is of the opinion that the request for removal is made in accordance with the provisions of Article 12(2) or (3) of this Proclamation.
2. Where a request for removal is made, in line with sub-Article (1) of this Article by the executive committee, it shall cause the matter to be presented to the appropriate council for deliberation.

15. *Penalty*

Who soever unlawfully disturbs or obstructs a council member from discharging his responsibilities or commits an act that injures the honour of a council member shall be punishable under the law.

16. *Effective Date*

This Proclamation shall enter into force as of the 19th Day of November, 1995.
