A PROCLAMATION TO ESTABLISH THE OROMIA PASTORALISTS DEVELOPMENT COMMISSION

WHEREAS, to date pastoralists have been given little attention in the region;

WHEREAS, it is necessary to enable the pastoralist communities to play a greater role in the economic development of the region through the mitigation of the adverse effect of change in climate on the lively hood of pastoralists and the national resource;

WHEREAS, it has been found necessary to establish by law a body that implements policies, strategies and programmes issued with the purpose of alleviating the socio-economic problems of the pastoralists;

Naannicha keessatti misoomni fedhii fi aadaa ummatichaan walsimatu qindoominaan akka raawwatamu taasiisuun hojii bu'a qabeessa ta'e raawwachuun barbaachisaa ta'ee waan argameef;

Heera Mootummaa Naannoo Oromiyaa Keewwata 49(3) (a) irratti hunda'uudhaan kan kanatti aanu lab-sameera.

1. *Mata Duree Gabaabaa*
Labsiin kun "Labsii Komishinii Misooma Horsiisee Bulaa Oromiyaa Hundeessuuf Bahe Lakk. 62 bara 1994" jedhamee waamamuu ni danda'a.

2. *Hiika*
Akkaataan seensa jechichaa hiika biraa kan kennisiisu yoo ta'e malee labsii kana keessatti:

- 1) "Mootummaa Naannoo" jechuun Mootummaa Naannoo Oromiyaati.
- 2) "Mana maree" jechuun Mana Maree Bulchiinsa Mootummaa Naannoo Oromiyaati.

4. *Gurmaawinaa fi Teessoo Komiishinichaa*

- 1) Komishinichi komishinaraa fi hojjeettoota barbaachisaa ta'an ni qabaata.

- 2) Komishinarichi Mana Mareetiin muudama.

- 3) Teessoon Komishinichaa teessoo Waajjira Mootummaa Naannoo Oromiyaa ta'ee, dameewwan qabaachuu ni danda'a.

5. *Kaayyoo*

Komishinichi kaayyoowwan armaan gadii ni qabaata:

- 1) Misooma dinagdee fi hawwaasummaa horsiisee bulaa naannicha keessatti argamu kallattidhaan ilaallatuu fi ittifufiinsa qabu hirmaannaa uummataatiin guddisuu fi jireenya ummatichaa fooyyessuu;

WHEREAS, it has been found necessary to implement development programmes in the region which is in harmony with the interest and traditional values of the pastoralist population,

NOW, THEREFORE, in accordance with Article 49 (3) (a) of the Constitution of the Oromia Regional State, it is hereby proclaimed as follows:

1. *Short Title.*

This proclamation may be cited as "The Oromia Pastoralists Development Commission Establishment Proclamation NO. 62/2002".

2. *Definitions*

In this proclamation;

- 1) "Regional state" means the Oromia Regional state.
- 2) "Council" means the Oromia Regional Administrative Council.
- 3) "Pastoralist" means people living in different areas but similar agro-climatic zones whose livelihood lies completely or mainly on livestock production or by their products.

3. *Establishment and Accountability.*

- 1) The Oromia Pastoralists Development Commission (here in after referred to as the "Commission") is established by this Proclamation.

- 2) The Commission shall be accountable to the Rural and Agricultural Supreme Office of Oromia.

4. *Organizational Structure and Head Office*

1. The Commission shall have a Commissioner and necessary staff.
- 2) The Commissioner shall be appointed by the Council.
- 3) The Commission shall have its head office in the capital city of Oromia and branch offices where necessary.

5. *Objectives*

The Commission shall have the following objectives

- 1) to promote sustainable socio economic development of pastoralists through their increased direct involvement and thereby to improve their living conditions;

2) Teeknooloojii ammayyaa, aadaa fi haala naannoo horsiisee bulaatiin walsimu babal'isuudhaan omish-tummaa guddisuu fi wabii nyaataa horsiisee bulaa mirkaneessuu.

6. *Aangoo fi Hojii*
Komishinichi:

- 1) Horsiiisee bulaa ilaalchisee yaada imaammataa fi tarsii-moo ni burqisiisa; yeroo hayy-amamu hojii irra ni oolcha.
- 2) Horsiiisee bulaa ilaalchiisee qo-rannoo barbaachisaan akka ga-ggeessamu ni taasisa; ragaa adda addaa walittiqaabuudhaan ni qindeessa, sagantaa misoommaa ittifufiinsa qabu ni qopheessa; hojiirras ni oolcha.
- 3) Misoomni fi kunuunsi qabeenya uumamaa, jireenya horsiisee bulaa akkaataa itti fooyyes-suu danda'uu fi uumama naan-noo isaatiin wal-simatu irratti yaada ni burqisiisa, qaama dhi-mmi ilaalu waliin ni hojjata.
- 4) Biiroollee dhimmi ilaaluuf sag-antaalee fi pirojektoota horsiisee bulaa ilaallatan qopheess-uuf odeeffannoo gargaaran ni kennaaf; bu'a qabeessummaa isaas ni hordofa.
- 5) Abbootii qabeenya dhunfaa fi qaama miti mootummaa naan-nicha keessatti argaman miso-oma naannoo horsiisee bulaa irratti akka hirmaatan ni jajjab-eessa; ni hordofa.
- 6) Raawwatiinsa sagantichaa fi pirojektootaaf fandii yookiin qabeenya biroo haala itti arga-muu danda'u ni barbaada, qaama Mootummaa Naannoo YKN waldaa Ummata dhi-mmi ilaaluun akka hojii irraa oolu ni taasisa.
- 7) Naannoo horsiisee bulaa kees-satti qaamota adda addaatiin misoomni baadiyyaa gaggeeff-amu haala itti qindaa'u ni mije-essa; bu'a qabeessummaa isaa-niis ni hordofa.
- 8) Horsiiisee bulaa ilaalchiisee le-enjiin akka qophaa'u ni taasi-sa; raawwannaa isaas ni hord-ofa.
- 9) Qabeenya ni horata; ni hima-ta; ni himatama.
- 10) Naannoo horsiisee bulaatti ragaa gabaa walittiqaba; ni qindeessa; furmaata rakkoo gabaa naannichaa ni burqisiisa; qaama dhimmi ilaalu waliin tauudhaan mala bu'u-ura misoomni gabaa itti ba'a-al'atu ni mijeessa.

- ፬ ጉዳዩ ለሚመለከታቸው ቢሮዎች የአርብቶ አደሩን የልማት ፕሮግራሞችና ፕሮጀክቶች ለመንደፍ የሚረዱ የተለያዩ መረጃዎችን ይሰጣል፤ ውጤታማነታቸውንም ይከታተላል።

2) to promote and decimate appropriate technologies that suit the tradional practices and agro-climatic condition which enhance pastoralist productivity and create food security.

6. *Powers and Duties*

- 1) Initiate Policy and strategy ideas for pastoralist develop-ment and implement same when approved.
- 2) Conduct studies, collect and organize information related to pastoralists, prepare a sus-tainable development programme for pastoralists and implement same when approved.
- 3) Initiate ideas and activities to be undertaken in the develop-ment and conservation of national resources which are environmentally friendly and implement same in collaboration with concerned bodies.
- 4) Provide information that enable concerned bodies to prepare pastoralist oriented programme and projects and follow up implementation and achievement of same.
- 5) Encourage and follow up private investors and non governmental organizations in the Region to participate in pastoralists development ac-tivities.
- 6) Mobilize fund or other resour-ces for the implementation of the programmes and projects, make the concerned regional goverment bodies and public organizatios to utilize same.
- 7) Coordinate and establish working relations among dif-ferent institutions working in pastoral areas and follow up the implementation and achievement of same.
- 8) Organize trainings to the pas-toralists; and then evaluate and follow up the implemen-tation of the same.
- 9) Own property sue be sued in its own name.
- 10) With collaboration of the con-cerned institutions working in pastoralist areas, collect and or-ganize marketing information and formulate possible solutions for problems related to marketing their products.

 - 12) Naannicha keessatti qabeenya beeyiladaa, dheedumsa fi uumamaa argamanuuf kunuunsi fi eegumsi addaa haala itti godhamuun mala ni barbaada, ni hordofa.

Komishinarichi aangoo fi hojii kanatti aanu ni qabaata:
- 1) Hojiiwwan Komishinichaa olaantummaadhaan ni gaggeessa; ni bulcha; ni to'ata.
 - 2) Baajata Komishinichaa qopheessuun qaama ilaallatuuf ni dhiyeessa, yeroo hayyamaamus hojiirra ni oolcha.
 - 3) Caasaa komishinichaa ni qopheessa; yoo hayyamame hojii irra ni oolcha.
 - 4) Seera Bulchiinsa Hojjatoota Mootummaa Naannoo Oromiyaa irratti hundaa'uudhaan hojjataa ni qacara; ni bulcha, akkasumas hojii irraa ni gaggeessa.
 - 5) Akkuma barbaachisummaa isaatti, hojjatoota isaatiif bakka bu'iinsa ni kenna.
 - 6) Komishinicha bakka bu'ee qaamota adda addaa waliin waliigaltee ni seena, walqunnamtii hojii ni uuma.
 - 7) Qaama dhimmi ilaallatuuf hojii isaa ilaalchiisee gabaasa ni dhiyeessa.
 - 8) Hojii biroo kennamuuf ni raawwata.
8. *Baajata fi Madda Galii Biroo*
Komishinichi hojii isaa kan gaggeessu;
- 1) Baajata Mootummaa Naannichaa irraa ramadamuun;
 - 2) Gargaarsa yookiin kennaa adda addaarraa maallaqa yookiin qabeenya biraa argamuun ni taha.
9. *Sanadootaa fi Galmeewwan Herregaa.*
- 1) Komishinichi sanadaa fi galmee herregaa guutuu ni qabaata.

- 11) In collaboration with bodies engaged in water development, formulate ideas and strategies to ameliorate problems related with water scarcity; follow up and evaluate its implementation and achievement.
 - 12) Seek means of conservation and protection of animals, range and natural resources in the pastoralist areas & follow up the implementation.
7. *Powers and Duties of the Commissioner*
The Commissioner has the following powers and duties:
- 1) manage, administer and supervise the activities of the Commission;
 - 2) prepare the budget of the Commission and implement same upon approval;
 - 3) prepare the organizational structure of the commission and implement the same on approval;
 - 4) employ, administer and dismiss employees in accordance with the Civil Service law of the region;
 - 5) delegate its power to the extent it is necessary;
 - 6) on behalf of the Commission enter into agreement with other bodies, and communicate with;
 - 7) submit periodic report to the concerned bodies regarding its activities;
 - 8) carry out other activities assigned to it.
8. *Budget and Sources of other Income.*
The budget of the Commission shall:
- 1) budget allotted by Regional Government.
 - 2) donation and assistance.
9. *Books of Accounts*
- 1) The Commission shall maintain proper and complete books of accounts and financial documents.

11. *Aangoo Qajeelfama Baasuu*
Komishinichi dhimmoota labsii kana keessatti xuqaman haala barbaachiisaa ta'een hojii irra oolchuuf qajeelfama baasuu ni danda'a.
12. *Yeroo Labsiin Kun Itti Ragga'u*

10. *Inapplicable Laws*
Any law or directive or regulation inconsistent with this proclamation shall have no effect with respect to matters provided for in this proclamation.

11. *Power to Issue Directives*
The Commission shall have the power to issue directives for the proper implementation of the matters provided in the proclamation.

12. *Effective Date.*
This proclamation shall come into force as of the day 11th of August 2002.
