organ that will effectively implement
the economic development and soci-
al policies, strategies and plans of the
Region;

WHEREAS, it is necessary to merge
some of the executive organs es-
tablished during the transition period in
consideration of the nature and volume
of their work as well as the
proper utilization of manpower and
material resources;

WHEREAS- it has further been
deemed necessary to define the power
NOW THEREFORE, in accordance
with Article 49(3) (a) of the
Constitution of the Oromia Region-
al State, it is hereby proclaimed as
follows.

CHAPTER ONE**1. Short Title**

This Proclamation may be cited as the “Establishment of the Executive Organs of the Oromia Regional State Proclamation No. 7/1995”.

2. Definitions

In this Proclamation, unless the context requires otherwise:

- a) “State ” means the Oromia Regional State.
- b) “Council” means the Council of the Oromia Regional State.
- c) “Executive organ” means an organ established under Article 3 of this Proclamation.
- d) “Region” means the Oromia Region.
- e) “Executive Committee” means the Executive Committee of the Oromia Regional State.

3. Establishment

The following executive organs are hereby established:

- a) the Culture and Information Bureau;
- b) the Education Bureau;
- c) the Water Resources, Mines and Energy Bureau;
- d) the Public Servants Administration Bureau;
- e) the Trade, Industry and Tourism Bureau;
- f) the Public Health Bureau;
- g) the Finance Bureau;
- h) the Transport and Communications Bureau;
- i) the Labour and Social Affairs Bureau;
- j) the Public Works and Urban Development Bureau;
- k) the Disaster Preparedness and Prevention Commission
- l) the Planning and Economic Development Bureau;
- m) the Agricultural Development Bureau;
- n) the Justice Affairs Bureau;
- o) the office of the Auditor General;
- p) the Investment Office;
- q) the Sports Commission;

4. Other Executive Organs That May Be Established

Without prejudice to the provisions of Article 3, the Council may establish other executive organs where appropriate.

5. Merger

a) the information Bureau and the Cultural affairs part of the Central and Sports Affairs Bureau have merged under the designation “the Culture and Information Bureau”;

b) the Mines and Energy Bureau and the Water resource Development of the Natural Resources Development and Environmental Protection Bureau have merged under the designation “the Water Resources, Mine and Energy Bureau”;

c) the Trade and Tourism Bureau and the Industry and Handicrafts Bureau have merged under the designation “the Trade, Industry and Tourism Bureau”;

d) the Agriculture Bureau and parts but the Water Resource section of the Natural Resources Development and Environmental Protection and the Tea fee and Tea Development Bureau have merged under the designation “the Agriculture Development Bureau”;

e) the office of the Attorney General that of the Police Commissioner as well as the Prison Administration of the Region have been integrated with the “Justice Affairs Bureau”;

6. Transfer of Rights and Obligations

The rights and obligations of the bureaus that have merged in accordance with Article 5 shall be transferred as follows:

a) rights and obligations of the bureau that has been dissolved shall be transferred to the newly established Bureau;

b) rights and obligations of the bureau parts of which are transferred by several bureaus shall be transferred to the Bureau that has taken the part which is the subject of the right and obligation.

7. Organization

1. Any executive organ established according to Article 3 shall be headed by a Bureau head who shall have the following organizations:

a) a head office situate at the City of the Region; and

2. Each bureau shall have a deputy head and other employees as may be necessary.

8. Appointment and Accountability

1. With the exception of the Regional Auditor General, all heads and deputy heads of the Regional executive organs shall be appointed by the Executive Committee upon submission of nominees by the President of the Regional State.

2. The heads shall be accountable to the Executive Committee and the President.

3. The deputy heads shall be accountable to the respective heads.

CHAPTER Two

POWERS AND DUTIES

9. Common and Individual Powers and Duties of Executive Organs

Executive organs established in accordance with Article 3 shall have common and individual powers and duties.

10. Powers and Duties common to all Bureaus

Each executive organ shall:

- a) enforce policies of the Federal and Regional Governments;
- b) draw up its work plan and budget and, upon approval, implement the same;
- c) ensure the enforcement of laws and directives;
- d) undertake research and evaluation works, collect and compile statistical data and submit the same to the Executive Committee;
- e) enter into contracts upon prior consultation with the Justice Affairs Bureau and Executive Committee;
- f) ensure the proper utilization of State funds and properties;
- g) unless otherwise decided, collect revenues against receipts to be issued by the Finance Bureau; and
- h) issue directives to properly discharge its functions provided for under the law.

- d) To facilitate, in cooperation with the concerned organs, conditions for the supply of gas petroleum and byproducts necessary to the Region;
- e) To ensure, in cooperation with the concerned organs, that the volume of energy reserve necessary to the Region is maintained;
- f) To encourage traditional mine exploitation, register mineral cooperatives, issue licence for construction mineral exploitation and supervise the same;
- g) Without prejudice to the powers and duties of the Federal Government:
 - i) to supervise the balance distribution and utilization

The powers and duties of the executive organs specified under Article 3(0) and (p) shall be determined by another law.

27. Powers and Duties of Branch Offices

Branch offices established in accordance with Article 7(1) (b) shall have the respective powers and duties provided for their head offices in their own hierarchy. The details shall be specified by directives to be issued by the concerned executive organ.

CHAPTER THREE

Powers and Duties of Bureau Heads

28. Powers and Duties of a Bureau Head

In addition to the powers and duties of the concerned Bureau provided for under Chapter two of this Proclamation, a Bureau head shall have the following powers and duties:

- to fulfill the manpower and material requirement of the Bureau and administer the same;
- to prepare the administrative structure and budget of the Bureau and submit the same to the Executive Committee;
- to represent the Bureau and establish working relationships with other concerned bodies;
- to participate, with no voting right unless he is a member of the Council, in the meeting of the Council or Executive Committee where necessary;
- to submit to the concerned organ draft laws necessary for the proper carrying out of the activities of the Bureau to which he is assigned;
- to submit periodic reports to the Executive Committee and President on the discharge of the functions of the Bureau;
- to perform such other functions as may be assigned to him.

29. Power and Duties of a Deputy Bureau Head

The Deputy Bureau head shall, on the basis of directives to be issued to him by the Bureau Head, have the following powers and duties:

- to assist the Bureau head in the implementation of the plans and programs of the Bureau;
- to represent the Bureau head in his absence and conduct the business of the Bureau;
- to perform such other functions as may be assigned to him.

CHAPTER FOUR
Miscellaneous Provisions30. Other Executive Organs

Without prejudice to the provisions of the Federal and Regional Constitutions, other executive organs shall resume their functions in accordance with their respective establishments laws.

31. Power to Issue Regulations

The Executive Committee may issue regulations for the proper implementation of this Proclamation.

32. Transitory Provisions

The Execution of works commenced prior to the coming into force of this Proclamation shall be continued though they were commenced by the concerned executive organ.

33. Repeal

- National Executive Organs of the Transitional Self-Government of Oromia shall hereby repeal Proclamation No.5/1994
- Any law which is inconsistent with the provisions of this Proclamation shall not apply with respect to matters provided for in this Proclamation.

34. Effective Date

This Proclamation shall come into force as of the 19th day of November 1995.
