Short Title This proclamation may be cited as the "reestablishment of proclamation No. 50/2002" and duties of the Executive bodies of Oromia Regional state (Amendment) proclamation No. 80/2004. 2. Amendments. The re structuring and re defining the Executive bodies of Oromia regional State Proclamation No. 50/2002, is hereby further amended as follows:

1. The phrase "Oromia Industry and Urban Development Bureau" stated under art. 12 sub art. 22 and art. 14 sub art. 4(b) of the proclamation is deleted and replaced by a phrase "design and construction Authority"
2. Art. 37 of the proclamation is deleted and replaced by the following.
"37 powers and duties of Design and construction Authority.
1. Prepares construction policies, strategies, rules and building codes for the under going construction projects in the Region and implements upon approval and cause others do the same.
2. Controls the standards and qualities of building designs and construction projects with in the region.
3. Prepares designs, specifications and engineering estimates for governmental construction projects Causes to be prepared and ratifies those prepared by different consultants.
4. Following the construction rules and regulations, undertakes the construction of building projects planed to be performed every year by the governmental bodies upon completion hands over the projects to the concerned owners.
5. Issues, renews and deletes professional licenses upon requests.
6. Evaluates requests of construction and consultancy licenses and cause to be provided Registers and follows up the performances of contractors in the region and take the necessary measures on those not doing their jobs accordingly.
7. Controls and ascertains correctness of the under going governmental construction bids, and other conducted and evaluated upon presentation.

11. Raawwii kenniinsa tajaajilaa fi babal'ina bu'ura misooma Bulchiinsa Naannoo Magaalotaa fooyyessuuf deegarsi dandeetti cimsuu akka kennamu ni taasisa.
12. Bulchiinsi Naannoo Magaalaa seerootaafi qajeelfamootaa eeguudhaan hojii isaanii kan raawwatan ta'uu ni mirkaneessa."

- ፲፩. በከተሞች አስተዳደር ውስጥ የአገልግሎት አሰጣጥንና የልማት አውታሮች መስፋፋትን ለማሻሻል የአቅም ግንባታ ድጋፎች እንዲሰጡ ያደርጋል።

8. Undertakes the renovation and maintenance of immense governmental buildings.
9. Facilitates the expansion of private contributions in construction sectors of the region.
10. Conducts researches upon naturally exciting construction materials, invents simple and efficient types of constructions and methods that can be exercised in the region.
11. Carry out assignments given and other functions related to its duties and responsibilities."
3. On powers and duties given to industry and Urban Development Supreme office under Article 18 of the Proclamation 50/94 the following new sub articles are added.
9. Provides urban cities development plans, to make their development universal.
10. Emanates basic policies and strategies to bring about fast developments and create good governance in urban cities of the Oromia region.
11. Provides capacity building supports to urban cities in order to improve their crevice delivery and infra structures.
12. Ratifies whether city administrations are accomplishing their assignments according to rules and regulations et.
4. The powers and duties conferred under Article 12 (23), 14 (5) (B) and 37 of the Proclamation upon the Public Affairs administration and Zone coordination Office are hereby transferred to Administration and justices supreme Office.
5. The power conferred upon Administration and justices supreme Office are enumerated under Article 19 (from sub-art. 10 through 20)
6. Effective date
This Proclamation shall enter into force as of the 8th day of March 2004.
