Proclamation No.84/2004

A Proclamation to Establish Oromia Regional State Security Council

WHEREAS, it is found necessary to
lay down a guaranteed system for
protection of the regional security
against both unforeseeable and
foreseeable circumstances that may put
it in danger;

WHEREAS it is essential to es-
tablish a legitimate security council at
regional, zonal, and Wereda level with
a view to guarnateeing stability and
security in the region as well as solving
in coordination all security related
problems therein;

NOW, THEREFORE, in accor-
dance with Sub-Article 3(1) of Article
49 of the Revised Constitution of
Oromia Regional State, it is hereby
proclaimed as follows:

1. Short Title

This proclamation may be cited as
"Proclamation to Establish
Oromia State Security Council
No. 84/2004."

2. Establishment

The Oromiya Regional State
Security Council (hereinafter
referred to as the "Security Coun-
cil") has been established by this
Proclamation.

3. *Kaayyoo Mana Mariichaa*

3. *Objectives of the Security Council*

Create working procedure and organization which enables to solve security problems that may be seen in the region in collaboration with other security organs.

4. *Organization*

1. Security Councils shall be organized at Regional, Zonal, Wereda and mayor-led-towns level.

2. Security Councils may be organized at Kebele level as necessary.

3. Security Council may comprise various committees as necessary.

4. The committees to be established, their members and job description shall be decided by the Regional Security Council.

5. *Accountability*

1. The Security Council of the Region, Zone or a mayor-led-town shall be accountable to the President of the Regional State.

2. The Woreda Security Council shall be accountable to the chairperson of zonal administration.

ሀ) በፀጥታ ጉዳዮች ላይ ይወያያል፤ ውሳኔም ያስተላልፋል።

ለ) በክልሉ ውስጥ ለፀጥታ ችግር የሆኑትን ጉዳዮች በዝርዝር በማስጠናት መፍትሄ ያስቀምጣል። አፈፃፀሙንም ይከታተላል።

ረ) በክልሉ ውስጥ በተፈጥሮ እና በሰው ሠራሽ በተነሳ አደጋ፣ ጉርፍ፣የደን ቃጠሎ፣ የመሬት መንቀጥቀጥና የመሳሰሉት በሚከሰቱበት ጊዜ ጉዳዩ ከሚመለከታቸው አካላት ጋር በመቀናጀት የተከሰተው አደጋ እንዲወገድ ያደርጋል። የደረሰ ጉዳት ካለ እርዳታ የሚገኝበትን (የሚሰጥበትን) ሁኔታ ያመቻቻል።

(b) May allow any person to be present at the meetings of the council in order to give his professional advice.

6. Without prejudice to Article 5(b), the chairperson of the security council of a Zone or Woreda or Mayor-led-town may grant permission to any person to be present at the meetings of the council in order to give his professional advice.

7. *Powers and Duties of the Security Councils*

1. Powers and Duties of the Regional Security Council

(a) Discuss and decide on Security matters.

(b) Cause studies pertaining to obstacles to the regional security and propose recommendations; follow up its implementation,

(c) Coordinate the exchange of information regarding the regional security and cause the planning and implementation of ways and means of safeguarding the security of the region on the basis of information obtained through such exchanges;

(d) Ensure the security organs work jointly to guarantee the rural and urban people are free from insecurity threat.

(e) Ensure that adequate and proper protection is extended to development undertakings of large-scale manufacturing, factories, inter-regional highways, sources of electricity, etc.

(f) Undertake the prevention of natural and man-made disasters such as flood, wildfire, earth quake, etc. in collaboration with the concerned bodies; facilitate conditions to provide support if danger occurs.

(g) Give instruction concerning control of illegal trade activities of arms, follow up its implementation.

5) Members of the security councils at all levels shall be jointly liable for any decision they make jointly.

8. Meeting Procedures

1. The security councils may meet at any time upon a call by the chairperson;
2. The meeting shall constitute a quorum when majority of the members present.
3. The security councils may issue an internal directive in respect of the time and procedure of their sessions.

9. Powers to Issue Regulation

The Oromia Regional Administrative Council may issue regulations to implement this Proclamation.

10. Effective Date

This Proclamation shall come into force as of 9th July 2004
