A PROCLAMATION TO PROVIDE HEALTH SERVICE DELIVERY AND ADMINISTRATION OF OROMIA REGION

WHEREAS, it has become necessary
 to make the health service delivery of
 Oromia Region standardized and sys-
 tematically managed and to administer
 all health institutions through uniform
 work procedure, follow up and
 supervision;

WHEREAS, it has become necessary
 to support the capacity of health service
 institutions and to establish central
 information system concerning the
 spread of diseases based on the preven-
 tive health policy of the government;

WHEREAS, it has become necessary
 to facilitate conditions through which
 governmental health institutions get ad-
 ditional source of income and to make
 their relation with private health ins-
 titutions smooth to improve their or-
 ganization, management and quality of
 service;

NOW, THEREFORE, in accordance
 with Article 49 (3) (a) of the Cons-
 titution of the Region, it is hereby
 proclaimed as follows:

PART ONE General Provisions

1. Short Title

This Proclamation may be cited as
 “Proclamation to Provide for
 Health Service Delivery and Ad-
 ministration of Oromia Region
 No. 93/2005.”

2. *Hiika*

Akkaataan seensa jeechichaa hiika biraa kan kennisisu yoo ta'e malee Labsii kana keessatti:

- 1) "Tajaajila Fayyaa" jechuun hordoffii, ittisaafi to'annaa dhukkuboota daddarbaa, qormaata qaamaa, laaboraatoorii, rajjiifi qormaata fayyaa kan biraa, kenninsa wal'aansa fayyummaafi barnoota eegumsa fayyaa tamsaasuu ni dabalata.
- 2) "Wal'aansa Tolaa" jechuun tajaajila fayyaa baasisaa qaamni Mootummaa dhimmi ilaalu ykn qaamni sadaffaan biraa danda'ee lammiilee kaffalanii yaalamuu hindandeenyeef tolaan kennamu jechuudha.
- 3) "Tajaajila fayyaa kaffaltiiti itti hingaafatamne" jechuun barmaata eegumsa fayyaa haawaasichaa ol guddisuuf akkasumas tajaajiloota fayyaa bu'aa guddaa qaban kennuu wajjin tajaajila kutaa hawaasaa hundaaf kaffaltiiti malee kennamu dha.
- 4) "Dhaabbata Fayyaa" jechuun hospitaala, buufata fayyaa fi keellaa fayyaa Mootummaa Naannoo Oromiyaa jalatti buluudha.
- 5) "Galii" jechuun galii dhaabbattoonni fayyaa tajaajila fayyaa kennanirraa, gurgurtaa qorichaa, gurgurtaa tajaajiloota biraa fi meeshaarraa argatan, akkasumas gargaarsa akaakuufi maallaqaan argataniidha.
- 6) "Qaama sadaffaa" jechuun dhaabbata dhuunfaa ykn Mootummaa kan bifa inshuuraansiifi bifa biraatiin baasii fayyad-moota tajaajilaa danda'u jechuudha.
- 7) "Dhaabbata fayyaa dhuunfaa" jechuun dhaabbattoota fayyaa kanneen abbootii qabeenyaa dhuunfaafi dhaabbata miti mootummaatiin tajaajila fayyaa kennuuf seeraan heyya-mameef ni dabalata.
- 8) "Biirroo" jechuun Biirroo Eegumsa Fayyaa Mootummaa Naannoo Oromiyaati.
- 9) "Qaama baasii kaffalu" jechuun qaama baajata qabatee baasii fayyaa kutaalee hawaasaa kaffalanii tajaajilamuuf dandeettii hinqabneef kaffaluu jechuudha.

- ፩ "የጤና አገልግሎት" ማለት የተላላፊ በሽታዎችን መከታተል፣ መከላከልና መቆጣጠር፣ የአካል፣ የላብራቶሪ፣ የራጅና ሌሎች የጤና ምርመራዎች፣ የፈውስ ሕክምና አገልግሎትና የጤና አጠባበቅ ትምህርቶችን ያጠቃልላል።

- ፫ "ከፍተኛ የማይጠየቅበት የጤና አገልግሎት" ማለት የሕብረተሰቡን የጤና አጠባበቅ ልምድ ከማሳደግ እንዲሁም በሕዝብ ጤና አጠባበቅ ጉልህ ጠቀሜታ ያላቸውን የጤና አገልግሎቶች ከመስጠት ጋር በተያያዘ ለሁሉም የማሳበረሰብ ክፍል ያለከፍቶ የሚሰጥ አገልግሎት ነው።
- ፬ "የጤና ተቋም" ማለት በክልሉ መንግሥት ሥር የሚተዳደር ሆስፒታል፣ ጤና ጣቢያና፣ ጤና ኬላ ነው።
- ፭ "ገቢ" ማለት የጤና ድርጅቶች ከሚሰጡት የጤና አገልግሎቶች፣ ከመድኃኒት ሽያጭ፣ ከሌሎች አገልግሎቶች እና ዕቃዎች ሽያጭ የሚያገኙት ገቢ እንዲሁም በዓይነትና በገንዘብ የሚያገኙት እርዳታ ነው።
- ፮ "ለስተኛ ወገን" ማለት የአገልግሎት ተጠቃሚዎችን ወጪ በኢንሹራንስ ወይም በሌላ መልክ የሚሸፍን የግል ወይም የመንግስት ድርጅት ማለት ነው።
- ፯ "የግል ጤና ድርጅት" ማለት በጤና ዘርፍ ከመንግሥት መዋቅር ውጭ በግሉና መንግሥታዊ ባልሆኑ ድርጅቶች የጤና አገልግሎት እንዲሰጡ በሕግ የተፈቀደላቸው ድርጅቶችን ያጠቃልላል።
- ፰ "ቢሮ" ማለት የኦሮሚያ ክልል ጤና ቢሮ ማለት ነው።
- ፱ "ወጪን የሚሸፍን አካል" ማለት በጀት መደብ የመከፈል አቅም ለሌላቸው የኅብረተሰብ ክፍሎች የሚወጣውን የጤና ወጪ የሚሸፍን አካል ማለት ነው።

2. *Definitions*

Unless the context requires otherwise, in this Proclamation:

- 1) "Health Service" means follow up, prevention and control of communicable diseases, physical, laboratory, X-ray and other medical examinations, treatment service and dissemination of health education.
- 2) "Fee Waiver" means health service provision to citizens who cannot afford payment covered by an appropriate governmental body or other third party.
- 3) "Exempted Health Service" means health service provided free of charge to promote traditional health care of the society as well as giving health service which have great value to the public at large.
- 4) "Health Institution" means hospital, health center and health post under the Regional State.
- 5) "Revenue" means income accruing to health institutions from health service they render, sale of drugs, sale of other services and goods and donation obtained in cash or in kind.
- 6) "Third Party" means private or governmental organization which finances expenditures of beneficiaries of medical services by insurance or other schemes.
- 7) "Private Health Institution" means health institutions of private and non-governmental organizations licensed to give health service.
- 8) "Bureau" means the Health Bureau of Oromia Regional State.
- 9) "Health Expenses Financing Organ" means an organ which covers the medical expenses of people who cannot afford to pay by appropriating budget.

10) “Damee wal’aansi dhuunfaa keessatti kennamu” jechuun damee idilee hoospitaaloonni tajaajila wal’aansa idilee itti kennaniin ala, damee hoospitaalichaa tokko ta’ee hundeeffamuufi wal’aanamtoota deddeebi’anii ykn ciisanii wal’aanamaniif tajaajilli yaalaa itti kennamu jechuudha.

11) “Mana Marii” jechuun Mana Marii Bulchiinsa Mootummaa Naannoo Oromiyaati.

3. *Qajeelfama Bu’uuraa*

1) Dhaabbattoonni fayyaa mootummaa tajaajila fayyaa kan kennan kaffaltii Manni Marii murteessurratti hundaa’uudhaan ta’a.

2) Keewwata kana keewwata xiqqaa (1)n kan tumame akkuma jirutti tahee namni kamiyyuu sababa waan kaffalu dhabuutiin tajaajila fayyaa argachuu irraa hin dhoorkamu.

3) Namni kamiyyuu qaamoota waraqaa ragaa tolaa kennuf aangoon Mana Marii naannichaatiin kennameef irraa waraqaa ragaa yoo dhiyeeffate tajaajila wal’aansa tolaa ni argata; tartiibni isaa danbii Labsii kana hojiirra oolchuudhaaf baahuun murtaa’a.

4) Tajaajila fayyaa fooyyeessuuf hirmaannaan ummataa sadarkaa hundatti hundaawee akka cimu ta’a.

4. *Dirqama Hayyama Argachuu*

Namni ykn dhaabbanni kamiyyuu tajaajila fayyaa dhuunfaa kennuudhaaf hayyama ogummaa qaama dhimmi ilaallatu irraa argachuu qaba.

5. *Hojiiwwan Qorichaafi Meeshaalee Yaalaa Wajjin Walqabatan.*

Hojiin qorichaafi meeshaalee yaalaa wajjin walitti dhufeenya qabu kan akka biyya alaa irraa fichisii-suu, biyya keessatti oomishuu fi kkf kan raawwatamu akkaataa seera seerummaa qabuun ta’a.

፭ ከመድኃኒትና የሕክምና መሳሪያዎች ጋር ስለሚያያዙ ሥራዎች

መድኃኒትና የሕክምና መሳሪያዎችን ከውጪ የማስመጣትና የማምረት እንዲሁም ከነኚህ ጋር የተያያዙ ማናቸውም መስል ስራዎች የሚከናወኑት አግባብ ባለው ሕግ መሠረት ይሆናል።

10) “Private Wing” means a unit established within hospital parallel to the general ward and provides inpatient and outpatient health services by charging a special service fee.

11) “Council” means the Regional Administrative Council of Oromia.

3. *Principles*

1) Health Institutions of the Region shall render medical services upon payment of fees determined by the Council.

2) Without prejudice to sub article (1) of this Article, no person shall be denied of medical service in health institutions due to his inability to pay.

3) Any person who produces fee waiver certificate issued by duly authorized body by the Council is entitled fee waiver. The details shall be determined by a Regulation to be issued to implement this Proclamation.

4) Public participation shall be strengthened at all levels to improve health service.

4. *Duty to Get License*

Any person or institution shall get professional license from the concerned body to render private health service.

5. *Activities Related to Drugs and Medical Equipments*

Activities related with drugs and medical equipments such as: importation, production and similar activities shall be carried out in accordance with the relevant laws.

6. *Organs of Health Service Administration*

The following are organs of health service administration of Oromia Region:

1) The Bureau and health offices at all levels;

- 2) Gumii Gorsitootaa;
- 3) Boordii Hoospitaalaa;
- 4) Maanajimantii Hoospitaalaafi Buufata Fayyaa, fi
- 5) Maanajimantii Keellaawwan Fayyaa.

7. Aangoo fi Hojii Biiroo Eegumsa Fayyaa

Biirichi aangoo fi hojii labsii biraan kennameef akkuma eegametti ta'ee dabalataan aangoofi hojii kan armaan gadii ni qabaata:

- 1) Baay'ina, gahumsaa fi akaakuu humna namaa dhaabbattoonni fayyaa qabaachuu qabaniifi sadarkaa gamoo, meeshaalee wal'aansaafi wantoota hojii isaaniitiif itti fayyadaman ni murteessa;
- 2) Dhaabbattoota dhuunfaa tajaajila fayyaa kennaniif hayyama ogummaa ni kenna;
- 3) Yaada dhaabbattoonni fayyaa Mootummaa Naannichaa dhiyeessanirratti hundaa'ee, kaffaltiin tajaajila kennaniif kaffalamuu qabu, baasii dhaabbattoota kanaa fi dandeettii ummatischea hubannoo keessa galchuu-saa mirkaneessuudhaan yaada-saa wajjin Mana Mariif dhiyeesssee ni murteessisa;

- 6) Dhaabbattoonni fayyaa mootummaa, mti-mootumma fi dhuunfaa tajaajilli fayyaa kennan kan sadarkaasaa eege ta'uu isaa ni to'ata;
- 7) Dhaabbileen fayyaa mootummaa haala qaama seerummaa itti argatan ni mijeessa;

7. Powers and Duties of Health Bureau

Without prejudice to the powers and duties vested in it under other proclamation, the Bureau shall:

1) Determine the number, qualification and composition of manpower, the standard of buildings, medical equipments and materials of health institutions;

2) Issue professional license to private health institutions;

3) Submit health service fee proposal to the council based on the recommendations presented by governmental health institutions taking into consideration the expenses of these institutions and the ability of the public to pay;

4) Give necessary assistance to strengthen efficiency of manpower, operational system and capacity of health institutions;

5) Issue directive to classify the standards of health institutions; standardize health institutions based on this directive;

6) Supervise the observance of the required standard of health service given by the governmental, non-governmental and private health institutions;

7) Facilitate conditions by which governmental health institutions acquire legal personality;

8) Supervise and follow up the observance of criteria, directives and regulations issued to promote the coverage and quality of health service;

8. Advisory Council

- 1) An advisory council, which serves as an advisor in the effort being done to improve the coverage and quality of health service, shall be established at the Regional level and others as necessary.

4) Any hospital which has legal personality shall not be liable beyond its assets.

5) The employees of the hospitals shall be administered in accordance with the Civil Service Law unless provided otherwise.

10. Professional Code of Ethics

1) The Bureau shall cause the health professional code of ethics be implemented; follow up its implementation.

2) Any professional or institution which gives health service shall observe the professional code of ethics.

11. Referral and Reception System

The referral and reception system of patients from one health institution to another shall be decided by a directive to be issued by the Bureau.

15. *Source of Finance*

Health institutions shall have the following source of finance:

- 1) Budget appropriated by the government;
- 2) Income derived from sales and medical services;
- 3) Aid and other income sources.

16. *Finance Administration and Revenue Utilization*

- 1) Health institutions are authorized to retain and utilize their income.
- 2) Income obtained by any health institution shall be deposited in a special bank account opened in its name.

19. Improving the Working Environment

The Bureau shall work in coordination with private bodies concerning policy, technique and work procedure to enforce professional code of ethics.

20. Assistance

1) The Bureau shall give assistance for private and non-governmental organizations which engaged in health service to expand and improve the quality of health service.

2) The Bureau shall cause private institutions to participate in training and preparation of work produces.

21. Organization of Information

- 1) The Bureau shall facilitate conditions by which exchange of information to be developed concerning the participation of private sectors in health service, to identify their problems and to take measures, undertake continuous study.
- 2) Governmental and private health institutions shall exchange reliable and timely information regarding the types and spread of diseases based on the directive to be issued by the Bureau.

22. Emergency Health Service

- 1) Private health institutions shall have the duty to participate in the control of epidemic diseases and emergency health services.
- 2) The Bureau shall cause the management of health service found at different levels and health institutions be equipped with sufficient information and logistics which can help them to prevent and control an epidemic.

PART SEVEN
MISCELLANEOUS PROVISIONS

23. Power to Issue Regulations and Directives

- 1) The Regional Administrative Council may issue regulations to implement this Proclamation.
- 2) The Bureau may issue directives to implement this Proclamation.

24. Inapplicable Laws

Any law inconsistent with this Proclamation shall not be applicable on matters specified in this Proclamation.

25. Effective Date

This Proclamation shall come into force as of the 3rd day of March 2005.
