Proclamation No. 97/2005

A proclamation to amend the Urban Water Supply and Sewerage Service Enterprises of Oromia National Regional State Establishment Proclamation No. 78/2004 Amendment

WHEREAS, it has become necessary to make the urban water supply and sewerage service enterprises established by Proclamation No. 78/2004 strong through administrative and technical works that enable them achieve their objectives.

NOW, THEREFORE, in accordance with Article 49 (3) (a) of the Oromia National Regional State Constitution, it is hereby proclaimed as follows.

1. Short Title

This proclamation may be cited as "The Proclamation to Provide for the Establishment of Urban Water Supply and Sewerage Service Enterprises of Oromia National Regional State Amendment Proclamation No. 97/2005."

2. Foyya'iinsa

Labsiin Lak. 78/96 akkaataa kanatti aanee jiruun fooyya'eera:

- 1) Tumaaleen keewwata 5 keewwata xiqqaa 4 jalatti aangoofi hojiin dhaabbatichaaf kenname akkuma eegameetti ta'ee kan kanatti aanu itti dabalameera.

"(a) Dhaabbatichi waliigaltee dhiyeessa bishaanii maammiloota wajjin mallatteessurratti ammantaa Meetir Kuubii kuusaa bishaanii ni murteessa;

- (b) Maammilli bishaanii kamiyyuu kuusaa bishaanii waliigaltee dhiyeessa bishaaniirratti murta'een ala akka hin ijaarre ni to'ata; ijaaramee yoo argamees seeraan akka jigu ni godha."

- 2) Tumaaleen keewwata 7 keewwata xiqqaa 1 fi 2 jala jiranu haqamanii akkaataa kanatti aanuun fooyya'aniiru:

"1)Boordii Bishaanii Biiroo Qabeenya Bishaaniitiin hundeeffamu:

- (a) Biiroon Qabeenya Bishaan Oromiyaa Boordii Bishaanii Dhaabbilee Tajaajila Bishaan Dhugaatiifi Dhangala'aa magaalota sadarkaa 1ffaa fi 2ffaa keessaatti argaman ni hundeesa;

- (b) Namni Biiroon bakka buusu walitti qabaa Boordichaa ni ta'a.

- (c) Boordichi miseensota Boordii Labsii Lak. 78/1996 keewwataa 7 jalatti tarree qubee (a)-(i) tti ibsaman ni qabaata; miseensonni kunis Bulchiinsa Magaalaa keessaa ykn alaa ramadamuu ni danda'u."

"2)Boordii Bishaanii Waajjira Qabeenya Bishaanii Godinaatiin hundeeffamu:

- (a) Waajjirri Qabeenya Bishaanii Godinichaa Boordii Bishaanii Dhaabbilee Tajaajila Bishaan Dhugaatiifi Dhangala'aa magaalota sadarkaa 3ffaa fi 4ffaa keessaatti argaman ni hundeesa;

- (b) Namni Waajjirri Qabeenya Bishaanii Godinichaa bakka buusu walitti qabaa Boordichaa ni ta'a;

2. Amendment

Proclamation No. 78/2004 is amended as follows:

- 1) Without prejudice to the powers and duties of the enterprise stipulated under Article 5 Sub Article 4 the following are added.

"(a) When signing the water supply contract the enterprise shall decide the capacity (M³) of the tanker.

- (b) It shall check the construction and capacity of water tankers of any client. If the client has built : tanker, which has more capacity than specified in the signed water supply contract, it has the right to demolish the water tanker according to the law."

- 2) The provisions of Article 7 Sub Article 1 and 2 are repealed and amended as follows:

"1) Establishment of Water Board By Water Resources Bureau

- (a) Oromia Water Resource Bureau shall establish Water Supply and Sewerage Service enterprises for 1st and 2nd grade urban towns.

- (b) A man assigned by the Bur shall be the chairperson of the Water Board.

- (c) The Water Board shall consist of board members stipulated under Article 7, sub Article (a) to (i) Proclamation No. 78/ 2004. The members could be assigned from or out of the towns Administration as deemed necessary.

"2) Water Board Established By Zonal Water Resource

- (a) The Zonal Water office shall establish Board for Water Supply and Sewerage Service Enterprises of 3rd and 4th grade urban towns.

- (b) A man assigned by the Zonal Water Resource Office shall be the chairperson of the Water board.

(c) Boordichi miseensota Boordii Labsii Lak. 78/1996 keewwata 7 jalatti tarree qubee (a)-(i) tti ibsaman ni qabaata.”

4) Waajjirri Qabeenya Bishaanii Godinichaa taarifa bishaanii Dhaabbata Tajaajila Bishaan Dhugaatiifi Dhangala'aa magaalota sadarkaa 3ffaa fi 4ffaa dhaan qoratamee dhiyaateef Biirroo Qabeenya Bishaanii wajjin mari'achuudhaan akkuma jirutti ykn fooyyessee ni raggaasisa; ni haqa; kan ragga'e hojiirra akka oolu ni taasisa.”

፬) የዞኑ ውሃ ሀብት ጽ/ቤት በ፫ኛና በ፬ኛ ደረጃ ከተሞች የመጠጥ ውሃና ፍላሽ አገልግሎት ድርጅቶች ተጠንቶ የቀረበለትን የውሃ ታሪፍ ከቢሮው ጋር በመመካከር የውሃ ታሪፍ በሙሉ ወይም አሻሽሎ ያፀድቃል፤ ይሰርዛል፤ የፀደቀውን ሥራ ላይ እንዲውል ያደርጋል፡፡”

(c) The Water Board shall consist of board members stipulated under Article 7, Sub-Article (a) to (i) of Proclamation No. 78/2004.

3) While amending the stipulations of accountability, powers, and duties of urban water boards provided under Article 8, Sub Articles 8(1), 8(2), and 8(3) shall be read as 8(5), 8(6), and 8(7).

1) The Water Board of 1st and 2nd grade Urban Water Supply and Sewerage Service Enterprise shall be accountable to the Bureau, and has powers and duties stipulated under Article 8 of Proclamation No. 78/2004.

2) The Bureau shall rectify the water tariff studied by the Enterprise as a whole, amend or reject and implement the rectified tariff.

3) The Water Board of 3rd and 4th grade urban Water Supply and Sewerage Service Enterprise shall be accountable to the Zonal Water Resource Office, and have powers and duties stipulated under Article 8 of Proclamation No. 78/2004.

4) The Zonal Water Resource Office in consultation with the bureau, shall rectify the water tariff studied by the 3rd and 4th grade urban water supply enterprise as a whole, amend or reject and implement the rectified tariff.

3. Effective Date

This Proclamation shall come into effect as of 6 September 2005.
